Application in Standard Forms are invited from intending male candidates for engagement against **ONE (Unreserved) temporary post of DRIVER (on contingency basis)** in the establishment of the undersigned on **FIXED PAY of Rs. 15,000/-** (Fifteen Thousand) per month.

ELIGIBILITY :

1. The Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The Candidate must have a valid LMV Driving Licence issued by the competent authority.
3. The candidates must not be less than 18 years. Age criteria shall be guided by government guidelines and the determinative date shall be 01.01.2023.
4. Minimum Qualification of the candidates must be Class-VIII (Eight) Passed.
5. Preference will be given to experienced candidates.

HOW TO APPLY :

- 3) The applications must be accompanied with-
 - a. Two copies of recent coloured passport size photo,
 - b. Experience Certificate, if any
 - c. All SELF ATTESTED testimonials in support of their educational qualification and caste.
4. Candidates already in govt. service must apply through proper channel.
5. The candidates will have to appear in the Driving Test & Interview at their own expenses and no T.A. & D.A. is admissible in this respect.
6. All information about date of skill test and viva-voce shall be shared through SMS and Whatsapp. So, the candidates are asked to provide their phone number in their application forms.

- ii) The candidates who qualify the skill test will be called for a viva-voce of 15 marks.

- iv) No separate call letters will be issued individually for the skill test and viva-voce.
- v) The selection will be made purely on merit basis.
- vi) If any candidate found canvassing directly/indirectly, his/her candidature will be rejected.
