ELIGIBILITY:

- 1. The Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
- 2. The Candidate must have a valid LMV Driving Licence issued by the competent authority.
- The candidates must not be less than 18 years. Age criteria shall be guided by government guidelines and the determinative date shall be 01.01.2023.
- 4. Minimum Qualification of the candidates must be Class-VIII (Eight) Passed.
- 5. Preference will be given to experienced candidates.
