

Eligibility Criteria

The candidate must be an Indian citizen as defined in Article 5 to 8 of the Constitution of India.

The candidate must be a graduate from any discipline for the post of Office Assistant and Receptionist —cum- Data Entry Operator (Typist). For the post of Peon, candidate must be Class-VIII passed but below Higher Secondary.

- iii. The candidate for the post of Office Assistant should have Basic word processing skills and the ability to operate computer and skills to feed data, Good Typing Speed with proper setting of petition, Ability to take dictation and prepare files for presentation in the Courts, File maintenance and processing knowledge.
- iv. The candidate for the post of Receptionist —cum- Data Entry Operator should have excellent verbal and written communication skills, word and data processing abilities, the ability to work telecommunication systems (telephone, fax machines, switchboards etc.), proficiency with good typing speed.
- v. A candidate shall not be less than 18 years and upper age limit is 38 years in case of general category. The upper age limit relaxation is 5 years for SC/ST candidates; 3 years for OBC/MOBC candidates.
- vi. Application with self-attested copies on all testimonials regarding Educational qualification, computer certificate, age proof etc. along with 3 recent passport size photographs duly signed by the candidate on the reverse side can be sent through speed post or in an envelope personally in the "Office of the District Legal Services Authority, Karbi Anglong District Judiciary campus, Karbi Anglong, Diphu, Pin 782460" on or before 5th August, 2024 by 17:00 hours. Application shall be addressed to the Chairman, District Legal Services Authority, Karbi Anglong, Diphu. No application shall be entertained after the last date.

The candidate must have registered his/her name in any of the Employment Exchange in Assam.

- viii. List of eligible candidates with date of interview, venue etc. shall be uploaded in the Official Website of District Judiciary, Karbi Anglong i.e https://district.ecourts.gov.in/karbianglong in due course of time. No. Separate call letters will be issued.
- ix. Candidates shall appear at the interview, computer proficiency test etc. at their own cost. No. T.A./D.A. will be admissible for the same.

- x. Canvassing directly or indirectly will disqualify the candidature.
- xi. Posts are purely temporary, for one year only.
