MEETING OF SELECTION BOARD

Dated, Diphu the 31st of July, 2024.

A meeting of the Selection Board was held today i.e. on 31.07.2024 at 04:00 PM in the office chamber of the District and Sessions Judge-cum-Chairman, Selection Board, Karbi Anglong.

Agenda and Resolutions thereof:-**1. Advertisement No. 02/2024 dated 02.05.2024:**

The Board has noted that the vacancy position of UDA in the District & Sessions Judge establishment has changed. Shri Gyanjyoti Hazarika, UDA has been released on promotion and he has joined as Bench Clerk- Grade I in the establishment of District & Sessions Judge at Hojai. In that view of the matter, the earlier advertisement for the post of UDA vide Advertisement No. 02 dated 02.05.2024 is recalled and cancelled.

It is further resolved by the Board that fresh advertisement notifying 4 vacancies be published in the website of the District Judiciary. Candidates having the requisite qualification and working in any establishment in the District Judiciary anywhere in Assam will be eligible to apply.

This Board has noted the fact that the Assam District and Sessions Judges' Establishment (Ministerial) Service Rules, 1987 was enacted in the year 1987 when there were no CBI Court Establishment, Family Court Establishment, MACT Establishment *et al.* Post the year 2013, the recruitment of LD Assistants has been taking place through a common recruitment process conducted by the Hon'ble Gauhati High Court. Through the said centralised recruitment procedure, a Select list of candidates is prepared and the selected candidates are deputed to different wings of the District Judiciary, including the District Judges' Establishment, Family Court Establishment, MACT Establishment, CBI Court Establishment *et al.* Thus, the District Judges' Establishment in the Assam District and Sessions Judges' Establishment (Ministerial) Service Rules, 1987 be read to include the integrated district judiciary.

In view of the above, this Board has resolved that: (i) applications in standard forms shall be invited from experienced employees of the establishment of the District and Sessions Judges/CJM/MACT/Family Court/CBI Court of the State of Assam to fill up the 4 vacant posts of UDA in the establishment of the District & Sessions Judge, Karbi Anglong. (ii) They are to apply through proper channel along with an NOC from the same. (iii) No direct applications shall be entertained and shall be outright rejected. (iv) The eligible candidates will have to appear for the interview at their own expense. No TA/DA shall be provided. (v) Canvassing directly or indirectly by any candidate will lead to cancellation of his/her candidature. (vi) The mode of selection for the above mentioned posts shall be through interview/viva voce only. (vii) The selection will be made purely on seniority-cum-merit basis, after considering their ACRs and Service Books for the last 5 years.

This shall be put forth in the advertisement. The Advertisement be published positively on 02.08.2024 and the last date of receipt of application be fixed on or before 17.08.2024.

2. **Promotion/recruitment of Jarikarak:**

At present there are 3 clear vacancies of Jarikaraks in the establishment. This Board is of the view that there is also one anticipated vacancy. In that view of the matter, this Board resolves to recruit/promote 4 persons as Jarikaraks.

The Hon'ble Gauhati High Court vide Notification No. HC.XXXVII-56/2012/83/R.Cell dated 13.02.2020 had directed to uniformly consider the promotion of all Grade-IV employees, except Jarikarakas, to the post of Jarikaraks, in the light of Draft Assam District Court Employees Service Rules, 2018.

As, at present, all the Jarikaraks in this establishment are direct recruits, this Board has, thus, resolved to promote 3 Jarikaraks from the cadre of Grade-IV and the remaining 1 post shall be filled up by direct recruitment.

The advertisement for 1 post by direct recruitment shall be published on the website and a copy of the advertisement shall also be forwarded to DIPRO for wide publication in 2 newspapers as per Government guidelines.

In pursuance of the resolution adopted, this Board thus resolves:

(i) To invite applications from existing Grade-IV employees working in the District Judiciary anywhere in Assam, for filling up the vacant posts of Jarikarak (Grade IV) in the establishment of the District & Sessions Judge, Karbi Anglong. (ii) They are to apply through proper channel along with an NOC from the same. (iii) No direct applications shall be entertained and shall be outright rejected. (iv) The eligible candidates will have to appear for the interview at their own expense. No TA/DA shall be provided. (v) Canvassing directly or indirectly by any candidate will lead to cancellation of his/her candidature. (vi) The mode of selection for the above mentioned posts shall be through interview/viva voce only. (vii) The selection will be made after considering their ACRs and Service Books for the last 5 years.

It is also resolved that the selection for the post of Jarikarak will be through written examination of 30 marks followed by viva-voce of 20 marks. The eligible candidates will have to appear for the written examination and viva-voce at their own expense. Candidates having Computer skills/Driving skills etc. shall be preferred.

3. Petition dated 15.06.2024 submitted by Sri Umesh Basumatary, Computer Typist, regarding permission to apply for UDA:


The prayer of Shri Umesh Basumatary to apply for the post of UDA stands tentatively allowed. His results shall be kept in sealed cover subject to decision of the Writ Petition, being WP(C)/1055/2023. The Board has taken note of the Draft Assam District Court Employees Service Rules, 2018.

It is to be noted here that his seniority shall not be affected in respect of the above mentioned post if the decision of the Hon'ble High Court is in his favour.

4. Petition dated 01.07.2024 submitted by Sri Umesh Basumatary, Computer Typist, regarding extending time for conducting any test/interview for UDA posts:


In view of the resolution of Point No. (3), Point No. (4) stands rejected.




