ELIGIBILITY :

1. The Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The Candidate must have a valid **LMV Driving Licence** issued by the competent authority. The Driving License must be issued at least 3 years before the date of publication of this advertisement.
3. The candidates must not be less than 18 years. Age criteria shall be guided by government guidelines and the determinative date shall be 01.01.2024.
4. Minimum Qualification of the candidates must be Class-VIII (eight) Passed. The candidate whose qualification is HSLC passed or above will be given preference.
5. Preference will be given to experienced candidates.
6. Candidate must submit copy of his voter ID card or Employment Registration certificate issued by the Govt. of Assam.

HOW TO APPLY :

Intending candidates will have to submit their application in sealed envelope to **"The District & Sessions Judge, Karbi Anglong, Diphu -782460"** either personally or through post.

1. The applicants must superscribe "Application for the post of Driver" on the top of the envelope and must write their MOBILE Nos. on the top of the Standard Form respectively in red ink.
2. The applications must be accompanied with-
 - a. Two copies of recent coloured passport size photo,
 - b. Experience Certificate, if any
 - c. All SELF ATTESTED testimonials in support of their educational qualification and caste and copy of Driving License.
3. Candidates already in govt. service must apply through proper channel.

4. Canvassing directly or indirectly will disqualify a candidate.
5. The candidates will have to appear in the Driving Test & Interview at their own expenses and no T.A. & D.A. is admissible in this respect.
6. Incomplete application will be summarily rejected.

SELECTION PROCEDURE :


- i) The candidates who are found to be eligible shall have to undergo skill test of 50 marks.

- iv) No separate call letters will be issued individually for the skill test and viva-voce.
- v) The selection will be made purely on merit basis.
