
ORDER

Dated, Diphu the 1st April, 2024

For smooth and convenience accommodation of Judicial Officers posted at Karbi Anglong, a permanent allotment of residential quarters to the Judicial Officers is necessary. In that backdrop, the following arrangement is hereby made:
