

## **DISTRICT RECRUITMENT COMMITTEE**

### **RESOLUTION**

**(In respect of Karmabandhu )**

**Dated the 18<sup>th</sup> day of March, 2025.**

A meeting is held today i.e on 18.03.2025 at 4.:30 P.M in the chamber of the Ld. District Judge, Purulia by the District Recruitment Committee for necessary discussion regarding employment of 8+1=9 Karmabandhus as per existing Govt. order and the followings are resolved:-

1. The Office of the Ld. District Judge, Purulia has received one letter being Memo. No. 50/C dated 17.02.2025 wherein the Judge-in-charge, Nazareth, Raghunathpur has submitted that since the one (01) Karmabandhu / sweeper namely Sri Sushen Paramanik has resigned from his post on last 27.09.2024, as such one (01) Karmabandhu is required in the Sub-Divisional Court for proper cleaning of the Sub-Divisional Court. Apart from this the newly constructed (G+4) Court Building is going to be inaugurated very soon and as per office record it had already been decided by the District Level Building Committee, Purulia vide Resolution adopted on last 27.03.2024 that 08 persons are required to be engaged as Karmabandhu by the District Recruitment committee for regular maintenance work of the New Court Building.

2. The committee has hereby resolved to appoint 09 Karmabandhu (Part-time Sweeper) on a temporary basis on yearly contract at a monthly consolidated salary <sup>of</sup> Rs. 5000/- (Five thousand) per month by complying with the existing Government Rules. The post of Karmabandhu will be appointed in this Judgeship in view of Memorandum No. 2727-F, dated 20.05.2009, Govt. of WB, Finance Department read with Memo. No. 3421-F(P) dated 30.06.2014, Govt. of West Bengal, Finance Department (Audit) read with Memo. No. 7284-F(P2)/FA/O/2M-1 dated 27.11.2017, Govt. of West Bengal, Finance Department (Audit) and read with Memo. No. 4624-F(P2) dated 14.11.2024, Govt. of West Bengal, Finance Department (Audit). The committee has also resolved to complete the entire process by issuing employment notice within 28.03.2025.

3. It is further resolved by the committee that the employment will be purely on contractual basis and the proforma of the said notice mainly observed as follows:






