The applicants have to collect the Application form for the post of Karmabandhu / Sweeper from the Office of the Judge-in-Charge of Nazarath, Purulia during the working days and the last date of submission of the application form is 10.04.2026 (in working days) at the Office of the Judge-in-Charge of Nazarath, Purulia

The applicants have to read and fill the form carefully and to submit the duly filled up form to the Nazarath Section of this Judgeship.

2. Incomplete application forms shall be rejected.

3. All the supportive documents have to be attached with the application form.

4. No application form shall be received from the Postal Service.

The candidates have to appear before the Selection Committee on **18.04.2026 at 2:00 p.m** onward at the Chamber of the Chief Judicial Officer, Purulia along with all the testimonials including residential certificate, age proof, addhar card, qualification certificate, experience certificate, if any, and two (02) recent passport size photographs.

The willing candidates are also directed to appear at the Nazarath Section by **10:30 a.m on 18.04.2026** for necessary verification.
