The officer in-charge of the concerned police stations shall intimate the arrest of a person immediately to the duty advocates, **if such arrestee is not in a capacity to engage an advocate of his own choice,** in accordance with the duty roster and concerned advocates shall provide legal assistance if the accused person has sought for legal aid.
