In compliance to Order No. 24, dated the 24th April, 2013 & Notification No. 52, dated the 20th August, 2013 of the Hon'ble Gauhati High Court, Guwahati, the meeting for the month of February, 2025 is held today i.e., on 24.02.2025 at 4.15 p.m. at the Office chamber of the District & Sessions Judge, Morigaon, *in presence of the following Officers.*

In the meeting, the following agendas were taken up for discussion:

**Agenda No. 1:** Proper service/ execution of processes of Courts by the Police Station.

**Resolution:** The Committee discussed the matter in detail and acknowledged the support received from the Police Department in regard to serving processes. However, the Committee also requested the Police Department to take extra care to fix minor glitches that's coming on its way. In addition, the Committee also requested the Police Department to emphasize more on old pending cases.

**Agenda No. 2:** Setting up the newly sanctioned Court of Addl. District & Sessions Judge at Morigaon.

**Resolution:** As representative from District Administration remained absent in the meeting, the matter could not be discussed in details. However, the Committee suggested that considering the proposal to shift the Court and Office of the Consumer Forum, Morigaon to the Guest House of Tribal Sangha on rented basis is now shelved by the Government; the same place may be considered to host the Court and Office of the Addl. District & Sessions Judge, Morigaon. The Office of the District & Sessions Judge, Morigaon may conduct discussions with the Office Bearers of Tribal Sangha on this regard and report the matter to the Committee.

**Agenda No. 3:** Shifting of PSI Office and Malkhana on temporary basis due to construction of VWDC in the Court Campus.

**Resolution:** As informed by the PWD Building Division, the construction of G+3 building that will host not only the VWDC but also the PSI Office will commence shortly, the Police Department is requested to take steps to shift the PSI Office and Malkhana on a temporary basis.

The S.P., Morigaon has informed that there are materials lying in the Malkhana for cases disposed long ago and hence suggested if before shifting, the Malkhana can be cleared. Considering the suggestion, the Committee resolved that if materials for disposed of cases still exist in the Malkhana, necessary steps must be taken to destroy the same as per rules.
