In the meeting, the following agendas were taken up for discussion:

Agenda No. 1: Proper service/ execution of processes of Courts by the Police Station.

Resolution: The Committee discussed the matter in detail and acknowledged the support received from the Police Department in regard to serving processes. As of now, the process is running smoothly.

Agenda No. 2: Setting up the newly sanctioned Court of Addl. District & Sessions Judge at Morigaon.

Resolution: The matter was taken up with the District Administration represented by Shri Kangkan Jyoti Saikia, Assistant Commissioner, Morigaon, who informed the Committee that as of now they have not come across any suitable place to offer for the said purpose. However, the Committee requested the District Administration expedite the process and provide an update before the Committee accordingly.

The Committee, further requested the District Administration to explore if the Guest House of the Tribal Sangha situated near the Court Campus or the Office of the Project Director, Integrated Tribal Development Project may be made available for the said purpose, considering its proximity to the Court Campus.

Agenda No. 3: Provisions of alternate environment friendly mobile toilets, bio toilets in the Courts, regular garbage collections, cleaning of sewage tanks/ septic tanks of the respective Courts, as directed by the Hon'ble Gauhati High Court vide letter no. HC.XLV-456/2025/153/PM&P, dated 26.03.2025 in compliance with the direction issued by the Hon'ble Supreme Court of India in WP(C) No. 538/2023.

Resolution: The Hon'ble Gauhati High Court vide letter no. HC.XLV-456/2025/153/PM&P, dated 26.03.2025 in compliance with the direction issued by the Hon'ble Supreme Court of India in WP(C) No. 538/2023 has directed to coordinate with "Deputy Commissioner for provision of alternate environment friendly mobile toilets, bio toilets n the Courts, if necessary, and also to take steps for regular garbage collections, cleaning of the sewage tanks/ septic tanks of the respective Courts."

In this regard, following issues were discussed:

- 1. The District Administration is requested to explore the feasibility and provisions for setting up environment friendly Mobile toilets, Bio toilets in the Court campus in consultation with the District Judiciary;
- 2. As regular garbage collection from the Court campus is not happening at the moment, the District Administration is requested to look into the matter;
- 3. The Court of Special Judge (POCSO), Morigaon is functioning from the Campus of the District Administration, Morigaon. The toilets situated at the victim's waiting room has collapsed and not in usable condition. Considering that the infrastructure belongs to the District Administration, Committee requested to do the needful urgently.

Agenda No. 4: Any other issues.

Resolution: The Police Department is requested to look into the following matters and sensitize the I.O.s accordingly

- 1. Notice u/s 47 & 48 of BNSS must be given in vernacular language;
