**ADVERTISEMENT FOR THE POST OF PARA LEGAL VOLUNTEER (PLV)/ ADHIKAR MITRA
FOR THE OFFICE OF THE DISTRICT LEGAL SERVICES AUTHORITY, MORIGAON**

Applications are hereby invited in the Standard form as published in the Assam Gazette in part-IX from the residents of Morigaon District for selection of PLVs/Adhikar Mitra, who are desirous/willing to serve as PLV (Para Legal Volunteer)/Adhikar Mitra at different areas of Morigaon District.

A. WHO CAN APPLY:

- Teachers (including retired teachers);
- Retired Government Servants (Ex-servicemen) and Senior Citizens;
- Master in Social Work (M.S.W) Students and teachers;
- Anganwadi Workers;
- Doctors/Physicians;
- Students & Law Students (till they enrol as lawyers);
- Members of Non-Political Service Oriented NGOs and Clubs;
- Members of Women Neighbourhood Groups Maithri Sanghrams and other Self-Help Groups including marginalized and vulnerable groups.
- Educated prisoners with good behaviour, serving long term sentences in prisons
- Persons from tea tribe community residing in Tea Estate in the district
- Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.

B. HOW TO APPLY:

- Candidate are to submit their duly filled standard application (published in the Assam Gazette in part-IX) form along with three (2) copies of recent passport size photographs, self attested photocopies of all necessary testimonials in support of age, qualification and computer diploma/certificate etc. on or before **05:00 PM of 28-08-2025 (Thursday).**

2. The envelope containing the application form should be super scribed as **"APPLICATION FOR THE POST OF PARA LEGAL VOLUNTEER (PLV)"** and the same should be addressed to **"THE DISTRICT & SESSIONS JUDGE-CUM-CHAIRMAN, DISTRICT LEGAL SERVICES AUTHORITY, MORIGAON, ASSAM, PIN-782105"**.
3. The envelope containing the duly completed application form should be dropped in the drop box labelled "DROP BOX OF APPLICATION FOR THE POST PLVs" kept in the premises of the District Legal Services Authority, Judicial Court Premises, Morigaon.
4. No fee is required to make application for the aforementioned posts.

C. OTHER TERMS AND CONDITIONS:-

1. He /She must be a citizen of India.
2. The applicants should have the minimum qualification of Matriculation (10th Pass) and they should have the mindset to work for the marginalised section of the society.
3. The minimum age for the selection of Para Legal Volunteer should not be less than 21 years as on the date of 01.01.2025. Preferably, the PLVs shall be selected, who do not work up to the income they desire from their service as PLVs but they should have a mind-set to assist the needy in the society.
4. The work of PLVs do not carry any salary, remuneration or wage except honorarium fixed by District Legal Services Authority, Morigaon from time to time, as per Rules.
5. The applicant should submit their **mobile/contact number** in their application for further required communication, if any.
6. Incomplete application will be summarily rejected without assigning any reason thereof. No application will be entertained after the last date fixed. The decision of the Chairman, DLSA Morigaon in shortlisting the no. of candidate for interview and selection of PLVs shall be final.
7. Selected PLV shall be required to undergo training programme as per decision of the District Legal Services Authority, Morigaon.
8. In case of any objection pertaining to selection of PLVs, the decision of Chairman, District Legal Services Authority, Morigaon shall be final and binding to all concerned.
9. List of shortlisted eligible candidates, if any, will be notified in the official Notice Board as well as uploaded in the official website of Morigaon District Judiciary, i.e. **<http://morigaonjudiciary.gov.in/dlsa/indexdlsa>**
10. No TA/DA will be provided for appearing in the interview.
11. Canvassing, directly or indirectly, will disqualify the candidate.

D. SELECTION PROCESS:

On the basis of documents relating to experience & qualification, candidates shall be shortlisted. The names of those shortlisted candidates shall be published in our Notice board and official website <http://morigaonjudiciary.gov.in>. **No individual call letters shall be issued to the shortlisted candidates.**

The shortlisted candidates shall appear in **viva-voce** before the selection committee. Date, time and venue of the viva-voce shall be notified in due course only through our Official Website.
