In terms of advertisement dated 18th September, 2021 and notification issued by the undersigned vide Memo No. DJCHA/2024/909-914, dated 11th June, 2024, the candidate, namely, **Jakiruddin Ahmed** is hereby provisionally appointed as **Driver** against the vacant post created vide letter no. JDJ-11016/97/2017-ESTT-JUDI-Judicial/35 dated 12.03.2020 in this establishment in the earlier scale of pay of Rs. 14,000/- to Rs. 49,000/- with grade pay of Rs. 5,200/- per month and other allowances as admissible under the Rules, which was revised to **Rs. 14,000/- to Rs. 60,500/- with grade pay of Rs. 5,200/-** under R.O.P. Rules 2017, with effect from the date of joining.

He will be on probation for a period of **2 (two)** years from the date of his joining.


The Services of the aforementioned candidate shall be governed by "The New Defined Contribution Pension Scheme" issued by the Government of Assam, Finance (Budget) Department, vide office memorandum No. BW.7/2008/Pt/40, dated Dispur the 6th October, 2009. The candidate mentioned above will have to submit an undertaking to that effect at the time of submitting his joining report.

The aforementioned candidate is directed to join his duties within 7 (Seven) days from the date of receipt of this letter.

Police verification process will be initiated after joining of the candidate. In the event of an adverse police verification report, the service(s) of the above mentioned candidate will be liable for termination.

He is directed to submit his Medical Certificate of Fitness issued by any Govt. registered Medical practitioner to the undersigned within 1 (one) month from the date of his joining.


