- The sealed envelope containing quotation shall be marked as "Quotation for Supply of Stationery and Miscellaneous Articles"
- 2. It should contain the following documents:
 - a) A copy of PAN Card
 - b) A copy of upto date Trade License.
 - c) A copy of GST registration certificate.
- The firms should have an established shop dealing in Stationery and Miscellaneous accessories. Detail address of shop is to be furnished along with quotation for verification.
- 4. All pages of the document must be signed by an authorised person on behalf of the firm along with seal at the bottom.
- 5. The bidders to quote price for good quality Branded Products only.
- 6. Rate should be quoted both in words and figures excluding GST/Taxes without overwriting/cutting/erasing. GST/Taxes are to be shown separately against the bills, where applicable, which will be deducted at source.

- 7. The Firms should quote rate for the items which are mentioned in the items list provided along with the quotation without adding any extra item. However they are to add name of Company/Brand wherever required for suitable specification of the articles. The size or the quality is also to be specified by making necessary modification. The Bidders may mark "MRP" as the bid for the branded articles.
- 8. Rate quoted for each item will be final and valid for period of one year from date of award of contract. No further hike in the price of any item will be entertained. However, validity of award of contract may extend for further period of one year on same terms, conditions and rates.
- 9. Sample of the items should be submitted if and when necessary.
- 10. The bidder shall quote rate against the specified brand name, size, weight etc (where applicable) of the articles as per prescribed list/format appended herewith.
- 11. The articles will be purchased as per requirement and the same shall be delivered to the office of the CJM Establishment, Charaideo. The supplier will have to replace the rejected articles immediately at their own expenses.
- 12. The suppliers will also have to bear all the overheads & expenses etc. in connection with carting, packaging, transportation etc. in connection with the supply to the office.
- 13. The Chief Judicial Magistrate, Charaideo reserves the right to accept or reject any or all of the quotations in part or full, without assigning any reason thereof. Further he shall not be bound to accept the lowest bid.
