Terms & Conditions:

1. The candidate must be an Indian Citizen.
2. The candidate **must not be less than 18 years** and more **than 40 years** of age as on the date of his/her submission of application. The upper age limit is relaxable by 5 years for SC/ST(P)/ST(H) candidate and 3 years for OBC/MOBC candidates as per Office Memorandum No. ABP.6/2016/51 dated. 02.09.2020 of Govt. of Assam.
3. The minimum educational qualification is **HSLC passed** and candidate must hold a valid license to drive LMV/four wheeler vehicles.
4. Filed-up "Application Form" along with Age certificate, certificates and mark sheets regarding educational qualifications, valid Driving Licence, Caste Certificate from competent authority, Employment Exchange registration certificate along with 2 (two) recent passport sized photographs **must be dropped in the "Drop Box" placed at the premise of office of the undersigned**. Candidates submitting their applications by post/courier addressed to the **Office of the Chief Judicial Magistrate, Charaideo, Sonari, Pin Code-785690, Assam** shall be received in the drop box only. The candidates shall remain liable for postal/courier delay and non-delivery of their application in the drop box in due time. The undersigned shall reject/return all the applications received after due date.
5. All documents furnished with the application must be self-attested by the

candidates himself/herself.

6. Application shall be written neatly in block letters.
7. The applicant should address to the Chief Judicial Magistrate, Charaideo, Sonari, Assam, Pin-785690 and the name of the post should clearly be mentioned at the top of the envelope as **"Application for the post of Driver."**
8. Applications made in any other mode except as indicated above shall be summarily rejected without any communication.
9. Candidates should annex copies of their experience certificate, if any, which shall be considered as an added qualification.
10. Applicants those who are already in Government service should submit their applications through proper channel. They shall have to produce No Objection Certificate at the time of document verification and release order at the time of joining from their employer.
