

In pursuance of Hon'ble Court's letter no. 53312-339/A.D. Apptt. Dated 01.07.2019, **Sri Rakesh Kumar Tiwary**, Sub Judge, Madhubani and **Sri Lallan Kumar**, Sub Judge, Jhanjharpur have been designated as **Sub Judge-I -cum- A.C.J.M.-I-cum- Assistant Sessions Judge-cum-Judge** of small cause Court in the rank of Civil Judge (Sr. Div.) at Madhubani and Jhanjharpur respectively.

Accordingly, **Sri Rakesh Kumar Tiwary**, Civil Judge (Sr. Div.) Civil Courts, Madhubani is hereby, designated as **Sub Judge-I -cum- A.C.J.M.-I-cum Assistant Sessions Judge-II-cum Judge** of small cause Court, Madhubani as well as **Sri Lallan Kumar**, Civil Judge (Sr. Div.) Civil Courts, Jhanjharpur is hereby, designated as **Sub Judge-I -cum- A.C.J.M.-I-cum Assistant Sessions Judge -cum- Judge** of small cause Court, Jhanjharpur.

Since, **Sri Rakesh Kumar Tiwary**, Civil Judge (Sr. Div.) has already been designated as sub Judge-I -cum- A.C.J.M.-I, Madhubani vide order no. 33/2019 dated 05.02.2019. Hence, **Sri Tiwary** will take over charge of Assistant Sessions Judge-II, Madhubani from **Sri Sushil Kumar Dixit**, Addl. District and Sessions Judge-VII, Madhubani (Incharge P.O. of the Court of Assistant Sessions Judge-II, Madhubani) at once.

Similarly, **Sri Lallan Kumar**, Civil Judge (Sr. Div.) Sub Judge-III-cum-A.C.J.M.-III, Jhanjharpur is incharge P.O. of the vacant court of Sub Judge-I-cum-A.C.J.M.-I, Jhanjharpur himself. Hence, **Sri Lallan Kumar**, will assume charge of the court of the Sub Judge-I-cum-A.C.J.M.-I, Jhanjharpur and take over charge of the Assistant Sessions Judge, Jhanjharpur from **Sri Triloki Dubey**, Addl. District and Sessions Judge, Jhanjharpur (Incharge P.O. of the court of Assistant Sessions Judge, Jhanjharpur) at once.

**Sri Lallan Kumar**, Sub Judge-I-cum-A.C.J.M.-I, Jhanjharpur will remain incharge (Successor) of the vacant court of Sub Judge-III-cum-A.C.J.M.-III, Jhanjharpur till further order after assuming charge of the court of Sub Judge-I-cum-A.C.J.M.-I, Jhanjharpur.
