In the light of Letter No. 897 / Conv. dated 13.09.2024 received from the Convenor, Centralized Selection and Appointment Committee -cum- District and Sessions Judge, Patna Forty (40) candidates, details of which is mentioned in separate sheet, are hereby appointed as "Court Reader -cum- Deposition Writer" in the pay scale of Level - 4 (25500-81100) with other allowances admissible under the rules in the Judgeship of Madhubani.

The appointment is on probation for a period of Two years from the date of appointment / joining and shall be considered for confirmation only after the expiry of two years of completion of satisfactory service and terminable on the ground of unsatisfactory work and/or conductoring probation. The candidates are directed to join the post within 30 days from the date of receipt of appointment letter, failing which the appointment shall automatically stand cancelled. No T.A. shall be paid for this purpose.

The candidates are directed to bring the following certificates / documents and declarations in original at the time of joining for the post:

- 5. Declaration regarding non-payment or receipt of dowry,
- 6. Declaration to the effect that you have not been convicted in any case, by any Court of Law as well as you have not been dismissed from any Government Service.
- 7. Caste Certificate issued by the competent authority (in case of candidates of reserved Category) as per his/her selection category along-with Residential Certificate of Bihar,
- 8. Certificate of E.W.S. issued by the competent authority (in case of candidates selected in EWS category) based on income of the financial year 2021-2022 alongwith Residential Certificate of Bihar.
- 9. NOC/permission letter issued by the employer, if provided your employment details, while making online application for the post (if applicable),
- 10. Supporting document(s) for 'Ex-Servicemen'/'Ward of Freedom Fighter'/ 'Employee of Bihar Government', issued by the competent authority (if applicable),
- 11. Two recent colour passport size photograph, pasted on a 'A4' size paper and duly attested by a Gazetted Officer.

Further, in view of the direction contained in aforesaid letter, let a notice be issued (after issuance of appointment letters) and publish the same on the official website of Madhubani Judgeship for information to the candidates concerned so that they may collect the appointment letters from the office of the undersigned within one week from publication of the notice. Thereafter, the same will be dispatched through registered post to the candidates concerned.
