Sub:- Quarterly Inspection of Child Care Institutions by the Visitor Judge and Principal Magistrate JJB

Respected Sir/Madam,

The Juvenile Justice Committee. High Court of Madhya Pradesh has been receiving monthly inspection reports of CCIs from Visitor Judge (ADJ nominated by the District Judge) and quarterly inspection reports from Principal Magistrate, JJB. However, from certain districts reports are not received on time and in the format.

It has came to the notice of the JJC that to inspect Child Care Institutions (CCIs) and to fill the format sufficient time is required for this purpose. It was suggested that the inspection of all CCIs should be carried out on quarterly basis.

The matter was discussed with the Hon'ble Chairperson JJC and as directed by his Lordship, it has been decided that henceforth:-

- 1. Visitor Judge (ADJ nominated District Judge) should inspect all Child Care Institutions (CCIs) and Specialized Adoption Agency (SAA) and CWC in the District on <u>quarterly basis</u> and submit duly filled formats as circulated earlier (including new formats) to the JJC. Secretariat in every three months.
- Principal Magistrate. JJB should inspect only those CCIs meant for Children in Conflict with Law such as Observation Homes. Special Home and Place of Safety (in case same is located in the district) on <u>quarterly basis</u> and submit duly filled formats as circulated earlier (including new formats) to the JJC. Secretariat every three months.
- 3. In addition to other agenda of discussion in the District Level Co-ordination Meeting, the aforesaid reports should also be analyzed and discussed in the monthly District Level Meeting with the concern authorities/stakeholders and efforts should be made to address and resolve the issues. Further, in case any issue is not resolved and required intervention by the Juvenile Justice Committee, the fact of the same should be specifically communicated to the JJC through the monthly Co-ordination report.

In view of above directions of Hon ble Chairperson JJC, therefore, you are kindly requested to comply the directions accordingly.
