Terms and Conditions:

1. Candidates must not be less than 18 years or more than 40 years of age on 01-01-2026. The upper age is relaxable as per Govt. norms (Age Limit: For General- 18 to 40 years, for OBC/MOBC- 18 to 43 years and for SC/ST- 18 to 45 years).
2. Candidates must have passed Class X.
3. The applicant must have a valid LMV Driving License issued by competent Authority.
4. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card along with 3 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the Office of the undersigned.
5. Candidates serving in Govt. Department should submit their application through proper channel.
6. The applicants shall mention their **Mobile Numbers** in the application without fail.
7. The last date of receipt of application is **19th September, 2026** (till 5 PM). No application will be entertained after the last date. The appointing authority shall not be responsible under any circumstances for any postal delay.
8. Envelope containing application should indicate the name of the post applied for on the top in Block letters as – “APPLICATION FOR THE POST OF DRIVER (CONTRACTUAL)”.

9. The list of eligible candidates along with specific dates of Skill/Driving Test and Interview/Viva-Voce shall be uploaded in the Official website of Biswanath District Judiciary (<https://biswanath.dcourts.gov.in/>) in due course. No separate call letters will be issued. Applicants are requested to refer to the official website.

10. The eligible candidates shall be required to appear for Skill/Driving test followed by an Interview/ Viva-Voce.

11. The final selection will be made on the basis of the total marks obtained by candidates in Skill/Driving Test and Interview/Viva-Voce only.

12. The admission of candidates at all stages of the selection process will be purely provisional. At any time before or after the selection process, if it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature shall stand cancelled without any prior notice. Merely shortlisted in the list of the eligible candidates does not necessarily mean acceptance of candidature of any candidate, which shall be further scrutinized at every stage and the selection/appointing authority reserves the right to reject the candidature of any candidate at any time.
