2. Cases based on all types of police challan cases related to police station Rorawar will be returned from Judicial Magistrate Court No. 01 and will be instituted and considered by this court.

3. The cases related to public representatives will be settled by this court.

Court Additional Chief Judicial Magistrate, Court No. 02, Aligarh.

1. All types of police challan and complaint related cases related to Kotwali Nagar police station will be returned from Additional Chief Judicial Magistrate, Court No. 01 and will be instituted and considered by this court.

2. Cases based on all types of police challans and complaints related to police station officers will be returned from Judicial Magistrate Court No. 03 and will be instituted and considered by this court.

3. All types of police challan and complaint related cases related to Akrabad police station will be returned from Additional Chief Judicial Magistrate, Court No. 01 and will be instituted and considered by this court.

Court Additional Chief Judicial Magistrate, Court No. 03, Aligarh.

1. Cases based on all types of police challans and complaints related to police station Dehligate will be returned from the court of Additional Chief Judicial Magistrate, Court No. 01 and will be instituted and considered by this court.

2. All types of police challan and complaint related cases related to police station Janwa will be returned from Judicial Magistrate Court No. 01 and will be instituted and considered by this court.

3. The cases assigned to the session related to Police Station Iglas and Gonda under the jurisdiction of External Court Judicial Magistrate Iglas will be taken back from the Court Additional Civil Judge (CPC), Court No. 03 and will be instituted and framed by this court.

4. The second senior-most Additional Chief appointed in the district as a special court to decide the cases related to embezzlement of cooperative societies formed under Government Notification No. 804/Saat-Nyay-2-2001-216-77 dated 28 September 2001. Judicial Magistrate has been authorized. Therefore, all the criminal cases of this district related to embezzlement of cooperative societies will be withdrawn from the present considered court, Additional Civil Judge (CPC), Court No. 03, and will be instituted and framed in this court.

Court Additional Chief Judicial Magistrate, Court No. 04, Aligarh.

1. All types of police challan and complaint related cases related to Gandhi Park Police Station will be returned from the Judicial Magistrate Court No. 01 and will be instituted and considered by this court.

2. All types of police challan and complaint related cases related to Thana Tappal will be returned from Judicial Magistrate Court No. 01 and will be instituted and considered by this court.

3. Cases based on all types of police challans and complaints related to police station cyber-crime will be returned from the Chief Judicial Magistrate, Aligarh and will be instituted and considered by this court.

4. All types of police challan and complaint related cases related to Police Station Godha will be returned from Judicial Magistrate Court No. 01 and will be instituted and considered by this court.

Court Additional Chief Judicial Magistrate, Court No. 05, Aligarh.

1. Cases based on all types of police challans and complaints related to police station Sasnigate will be returned from the court of Additional Civil Judge (CPC), Court No. 02 and will be instituted and considered by this court.

2. Cases based on all types of complaints related to Police Station Rorawar will be returned from Judicial Magistrate Court No. 01 and will be instituted and considered by this court.

3. Under the jurisdiction of the External Court Judicial Magistrate Atrauli, the cases assigned to the session related to Police Station Atrauli and Palimukimpur will be withdrawn from the Court Additional Chief Judicial Magistrate, Court No. 01 and will be constituted and constituted by this Court.

Court Judicial Magistrate, Court No. 01

1. All types of police challan and complaint related cases related to Chharra police station will be returned from Judicial Magistrate Court No. 02 and will be instituted and considered by this court.

2. All types of police challan and complaint related cases related to police station Gabhana will be returned from the court of Additional Civil Judge (CPC), Cart No. 01, Aligarh and will be instituted and considered by this court.

3. Cases based on complaints related to Police Station Quarsi will be returned from Judicial Magistrate Court No. 02 and will be instituted and considered by this court.

4. The cases assigned to sessions related to Thana Khair and Pisawa under the jurisdiction of the External Court Judicial Magistrate Khair will be withdrawn from the Judicial Magistrate Court No. 02 and will be instituted and framed by this court.

Court Judicial Magistrate, Court No. 02

1. All types of police challan and complaint related cases related to Barla police station will be returned from Additional Civil Judge (CPC), Court No. 03 and will be instituted and considered by this court.

2. All types of police challan and complaint related cases related to Madrak police station will be returned from Additional Civil Judge (CPC), Court No. 03 and will be instituted and considered by this court.

3. All types of police challan and complaint related cases related to Chandaus police station will be returned from Judicial Magistrate, Court No. 03 and will be instituted and considered by this court.

4. Cases based on all types of complaints related to Police Station Civil Line will be returned from Judicial Magistrate Court No. 03 and will be instituted and considered by this court.

Court Judicial Magistrate, Court No. 03

1. All types of police challan and complaint related cases related to Harduaganj police station will be returned from Civil Judge (CPC)/Fast Track Court, Court No. 02 and will be instituted and considered by this court.

2. All types of police challan and complaint related cases related to Police Station Lodha will be returned from Judicial Magistrate Court No. 02 and will be instituted and considered by this court.

Civil Judge (J.D.)/Fast Track Court Court No. 01

1. All types of police challan and complaint related cases related to Mahila Thana will be returned from Judicial Magistrate Court, Cart No. 03, Aligarh and will be instituted and considered by this court.

2. The institution and trial of the case based on the complaint related to Mahuakheda police station will remain the same.

3. The institution and trial of domestic violence cases related to all the police stations of the district will remain the same.

Civil Judge (J.D.)/Fast Track Court Court No. 02

1. The institution and trial of all types of police challan and complaint based cases related to Gangiri police station will remain the same.

2. All types of police challan and complaint based cases related to Police Station Vijaygarh will be returned from Judicial Magistrate Court No. 02 and will be instituted and considered by this court.

3. The institution and trial of cases based on all types of complaints related to Bannadevi police station will remain the same.

Note: -

- 01- Apart from the above, the consideration of the files under consideration transferred under the special order will remain the same.
- 02- The institution and trial of cases related to the police stations under the jurisdiction of Rural Court Gabhana will remain the same.

This order will come into effect with immediate effect from 22-11-2023.
