Order No. 145 (G), Dated- Asansol the 20th day of July, 2024.

In response to the Employment Notification No. 01 dated- 06.03.2024 to fill up the vacancies of Bench Clerks in the Additional District & Sessions Judge, Fast Track Courts of this Judgeship of Paschim Bardhaman, five (05) applications were received by this office.

On scrutiny of these applications only one candidate namely Shri Asit Kumar Dey was found eligible for Walk-in-Interview. Accordingly, he was asked to appear in the Walk-in-Interview held on 16.05.2024.

After completion of Interview, the Additional District Judge, 2nd Court, Asansol-cum-Chairman of the Interview Committee sent the result to this office [in view of letter No. 428 dated- 17.05.2024]

On scrutiny of the result, it appears that Shri Asit Kumar Dey, S/o- Late Nira Pada Dey secured 12 marks out of 20 marks and the same was put up before the District Recruitment Committee, Paschim Bardhaman.

Now, as per resolution of the District Recruitment Committee, Paschim Bardhaman, it appears that the Committee has recommended the name of Shri Asit Kumar Dey for engagement as Bench Clerk (Peshkar) in the Additional District Judge, Fast Track Court under this Judgeship of Paschim Bardhaman. As per resolution of the District Recruitment Committee, Paschim Bardhaman, a letter was sent from this office to the Judicial Department, Government of West Bengal seeking necessary approval in this regard and the said approval has been received from the said department in view of their letter No. 219-JD/X/16M-64/19 dated- 15.07.2024.

Accordingly, in view of the resolution of the District Recruitment Committee, Paschim Bardhaman and also in view of the approval being letter No. 219-JD/X/16M-64/19 dated- 15.07.2024 of the Judicial Department, Government of West Bengal, Writers' Buildings, Kolkata- 700001, **Shri Asit Kumar Dey, S/o- Late Nira Pada Dey**, a VRS holder from CRPF is hereby selected for engagement in the post of Bench Clerk (Peshkar) of the Additional District & Sessions Judge, Fast Track Court(s) of this Judgeship, **purely on temporary basis and also on contractual basis for one (01) year, subject to satisfactory discharge of duty.**


Accordingly, issue engagement order in favour of Shri Asit Kumar Dey, fixing 01st day of August, 2024 as date of joining.
