Order No. 207 (G), Dated- Asansol the 21st day of September, 2024.

This Judgeship of Paschim Bardhaman is a newly created Judgeship started to function with effect from 10.09.2018 after bifurcation of the erstwhile Judgeship of Burdwan. After creation of this Judgeship of Paschim Bardhaman, a gradation list of the existing employees of this Judgeship as on 10.09.2018 was published. Since then, the said gradation has been altered due to various reason, viz. promotion of employees from lower post to upper post, superannuation of employees, recruitment of staff in different vacant position(s), resignation of some employees. In this regard, it is pertinent to mention that, some employees of this Judgeship have already prayed for necessary permission/order for updating their educational qualification mentioned in their official documents including the existing gradation list and those applications have not yet been disposed of. Considering the urgency of publishing the fresh/updated gradation list of the employees of this Judgeship, the said draft gradation list has been prepared and is hereby circulated without mentioning the educational qualification column. Such applications of the employees for updating their educational qualification in their official documents will be considered later on, since the matter is time consuming.

Further, in the said draft gradation list, some fields of some employees of this Judgeship, namely Feroz Alam, Tanushree Mandal, Manmohan Tudu and Parimal Pal have been left blank due to unavailability of such information in this office. Respective Drawing and Disbursing Officer(s) are hereby requested to submit those information, as mentioned in their Service Book, to this end with a copy of necessary document(s), within the stipulated date.


