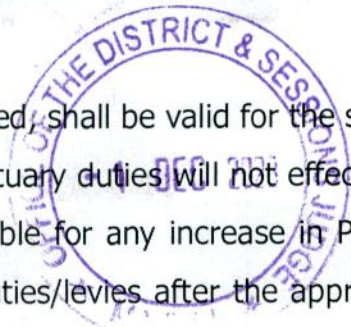

 - (c) Copy of Valid Trade Licence in Assam.
 - (d) OEM authorization certificate must be in top 3 vendors as per the latest I.D.C. report.
 - (e) OEM should be in IT business for at least 15 years in India.
 - (f) Copy of Bank Passbook having A/C No., IFSC and Branch.
2. Each page of the documents should be signed by the bidder with seal to establish the bidder eligibility and its quotation to perform the supply of materials if its bid is accepted.
3. In the absence of any of the above documents/information, the offer may be summarily rejected without making any further reference in this regard.
4. The sealed quotation should be submitted to office of the District & Sessions Judge, Majuli during working days.



5. The rates approved by the undersigned, shall be valid for the said item/items. Increase and decrease of Prices, Taxes and other statutory duties will not effect the price during this period of supply. The supplier will be responsible for any increase in Prices, Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approval of Rates shall be to the supplier's account.

6. The undersigned reserves the right to accept or reject any or all tenders in part or full without assigning any reason whatsoever.

7. The undersigned reserves the right, to award the work to one or more bidders. No communication shall be made in this regard except the selected firm/tenderer/bidder.

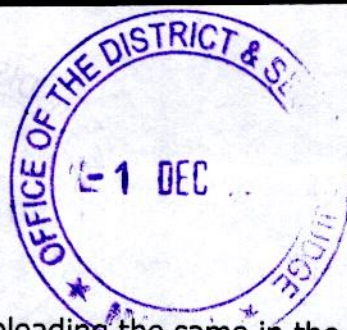
11. The decision of the undersigned in all respect shall be final and binding all.
