1. In no case, any tender submitted after the due date and/or beyond the stipulated time shall be entertained.
2. The undersigned reserves the right to accept and/or reject any tender without showing any reason whatsoever.
3. Tenders will have to come with original copies of documents of the vehicles.
4. In case of any deviation of condition of the vehicles, the authority shall reserve the right to cancel the contract with the supplier at any time during the aforementioned period.
5. The bidders should quote specific rates as per specific vehicles as per requirement. The bidders should have their G.S.T registration. The rates quoted by the bidders shall be as per the Govt., transport departments approved rates. The price quoted by the bidders shall remain fixed during the entire period of contract as per the agreement.
6. Payments on hiring of vehicles shall be made as and when budget and ceiling received from the Govt.
7. All valid documents including trade licence, G.S.T registration certificate, vehicle registration certificate, vehicle insurance policy, PUC, PAN card, up to date income tax, from competent authority, experience certificate and bank

account details are to be submitted along with quotations in printed letter head.

8. Chauffeur will have to be arranged by the owner of the car and pay and allowance of the chauffeur of the corresponding vehicles should be borne by owner of the Car and the undersigned shall have no liabilities in that regard. He is to report for duty as and when called for.
9. The contract may be terminated by a notice of one month from either side.
10. The contract will be for a period of one year from the date of actual hiring.
11. The fuel will be provided by as per the Govt. rule.
12. The entire general maintenance of the vehicle shall be borne by the bidder.
13. In case of mechanical breakdown, the supplier shall make available a replacement vehicle during the non-availability period.
14. The rates are to be quoted inclusive of all taxes must be in conformity with the specification as mentioned above.
15. The bidder whose quotation is accepted shall have to enter into an agreement with the authorized person. Legal jurisdiction of any dispute will be within the district of Majuli only.
