Applications in Standard Form are invited from intending eligible (male) candidates, who are citizens of India as defined in Article 5 and 6 of the Constitution of India, for filing up vacant post (highlighted in the table) in the establishment of Chief Judicial Magistrate, Majuli, Assam.

The qualification, eligibility criteria and reservation are set forth in the table against the post after taking into due consideration the relevant rules of government as amended from time to time.

**ELIGIBILITY:**

1. The Candidates who will fulfil the requisite eligibility criteria must submit their applications in the Standard Form of application published in the Assam Gazette Part-IX and fill the form with BLOCK LETTERS using Black/Blue ball pen only. Paste 1 (One) Recent passport size coloured photograph in the specified box and submit another 2 (Two) passport size photographs with the application form. Put applicant's signature in the box specified for signature. The applicants have to submit the application with a valid Driving license along with all the testimonials documents. The applicant have to appear in a driving test to be conducted by the District Transport Authority, Majuli.



2. The candidates must be an Indian Citizen as defined in Article 5 to 8 of the constitution of India.
3. The candidates must have a valid LMV Driving Licence issued by the competent authority.
4. The candidate must not be less than 18 years and not more than 40 years of age as on 01.01.2024. The upper age limit will be relaxed -
  - (i) By 5 years for ST and SC Candidates i.e upto 45 years as per the Govt. Notification No. ABP.6/2016/51, Dated 2<sup>nd</sup> September, 2020, Issued by the department of personal, Govt. Of Assam.
  - (ii) By 3 years of OBC/MOBC Candidates i.e upto 43 years as per the Govt. notification No. ABP.6/2016/51, Dated 2<sup>nd</sup> September, 2020 issued by the department of personal, Govt. Of Assam.
5. Minimum qualification of the candidates must be class X (Ten) passed.
6. Preference will be given to experienced candidates having valid work experience from any Govt. Department.

**HOW TO APPLY:**

1. Eligible candidates will have to apply in Standard Form of application (Published in the Gazette part IX of Govt. Of Assam) and same must be addressed to **“The Chief Judicial Magistrate, Majuli, P.O. Garamur Satra, PIN- 785104, Dist. Majuli, Assam”**, or may be dropped in the **“Drop Box for applications”** The last date of receipt of application is **19/08/2024** till office working hours. No applications received thereafter will be entertained.
2. The applicant must superscribe **“APPLICATION FOR THE POST OF DRIVER”** on the top of the envelope and must write their mobile number. On the top of the Standard Form respectively in red ink.
3. The application must be accompanied with-
  - a. 2 (Two) copies of recent coloured passport size photo.
  - b. Experience certificate, if any





c. All SELF ATTESTED testimonials in support of their educational qualification and caste certificate from competent authority, employment, exchange registration certificate.

4. Candidates already in Govt. Service must apply through proper channel. They shall have to produce NO Objection Certificate at the time of document verification and release order at the time of joining from the present employer, if selected.

5. The candidates will have to appear in the Driving Test & Interview at their own expenses and No T.A. & D.A. is admissible in this respect.

6. All information about date of skill test and Viva-voce shall be shared through SMS and Whatsapp. So, the candidates are asked to provide their whatsapp number in their application forms along with E-mail ID's.

7. The application can be submitted through ordinary/speed/Registered post or directly to the office of the undersigned. The office will not be responsible for any postal delay.

### **SELECTION PROCEDURE:**

1) The candidates who are found to be eligible shall have to undergo skill test of 20 marks.

2) The candidates who qualify the skill test will be called for a viva-voce of 30 marks.

3) The individual call letters will be sent to the eligible candidates through E-mode i.e Whatsapp & E-mail. The candidates have to mention their **Whatsapp Number and E-mail ID** at the top of the applications. List of eligible candidates for skill test and for viva-voce will be uploaded in the official website (**<https://majuli.dcourts.gov.in>**) of Majuli District Judiciary regularly to get updated information.

4) No separate call letters will be issued individually for the skill test and viva-voce.

5) The selection will be made purely on merit basis.



6) If any candidates is found canvassing directly/indirectly, his/her candidature will be rejected.
