#### **Terms and conditions:-**

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the constitution of India.
2. The candidates should not be below 21 years and above 45 years as on 1<sup>st</sup> January, 2024,
3. The interested candidates may appear before the Selection Committee with all self attested original documents, experience certificates etc, duly filed applications forms (enclosed herewith) along with self attested photocopies of the relevant testimonials including certificate of Length of Practice etc. and 02 (Two) copies of recent passport size Photographs, should be addressed to the District & Sessions Judge, Majuli, -cum- Chairman, District Legal Services Authority, Majuli.

5. The selected LADC's shall be initially on a **probation period of 3 (three) months** from the date of appointment and the contract period **shall be maximum of 2 (Two) years**.
