Applications are invited from the citizens of India as defined under Article 5 and 6 of the Constitution of India for filling up the vacant posts created vide Post creation letter no. JDJ/2021/43 dated 10.03.2022 (highlighted hereunder in the table) in the establishment of District & Sessions Judge, Majuli.

#### **ELIGIBILITY:-**

- 1. The candidate must be an Indian Citizen.
- 2. The candidate must possess the minimum educational qualification of VIII standard and those who have passed HSSLC or above shall be ineligible to apply for the said posts.
- 3. The candidate must not be less than 18 years and more than 40 years of age as on 01.01.2025. The upper age limit will be relaxed:-

District & Sessions Judge age

- (i) By 5 years for ST and SC candidates i.e. upto 45 years as per Govt. Notification No. ABP.6/2016/51, dated 02/09/2020 issued by Department of Personal, Government of Assam.
- (ii) By 3 years for OBC/MOBC candidates i.e. upto 43 years as per Govt. Notification No. ABP.6/2016/51, dated 02/09/2020 issued by Department of Personal, Government of Assam.

#### **HOW TO APPLY:-**

- 1. Eligible candidates will have to apply in standard Form of Application (published in the Gazeettee Part IX of Govt. Of Assam) and same must be addressed to "The District & Sessions Judge, Majuli, Garamur, PIN-785104." The last date of receipt of application is 21/12/2024 till 03.00 P.M.
- 2. All applications must be sent by "registered post/speed post" to the aforementioned address and on the envelope [Application for the post Peon/Chowkidar (whichever applied)] must be mentioned.
- 3. The application must be accompanied with the following:-
- (i) 2 (two) nos. of recent coloured passport size photographs with full signature on reverse side.
- (ii) Self-attested copies of testimonials in support of his/her AGE, CASTE and EDUCATIONAL QUALIFICATIONS, DRIVING LICENSE (if any) etc.
- (iii) The candidates must provide their phone number in their application form, written on the top of the Standard Form in RED INK.
- (iv) The Candidates have to submit a self-declaration certificate along with the application form stating that "he/she has not passed HSSLC or equivalent examination or above."
- 4. Candidates already in Govt. Service must apply through proper channel along with "NO OBJECTION CERTIFICATE" from the proper authority.
- 5. The applications must be submitted only through speed/registered post in the office of the undersigned. The office will not be responsible for any postal delay.
- 6. Incomplete or late received applications will summarily be rejected.

- 7. If the candidate is found to have suppressed his/her educational qualification or given any wrong information at the time of applying for the post, his/her candidature shall be rejected or his/her candidature will be terminated.
- 8. Copy of valid Employment Exchange Registration Certificate shall be provided with the application.

#### 9. SELECTION PROCEDURE:-

- (i) The list of eligible candidates shall be published in the official website of the district judiciary. A date for written examination to be held at Majuli shall be notified.
- (ii) There will be a written examination for the posts of peon followed by viva-voice. Candidates will have to appear for written examination and viva-voce at their own cost. No TA/DA shall be admissible. For the post of chowkidar, selection will be on the basis of personal interview.
- (iii) On the basis of marks secured in written examination, selected candidates will be called to appear for viva-voce.
- (iv) Preference shall be given in viva-voce to candidates having driving/plumbing/electrical skills.
- (v) The selection will be made purely on merit basis.
- (vi) The appointing authority reserves the right to reject over-qualified candidates.
- 10. At the time of examination or the interview as the case may be, the candidates must bring their photograph, original testimonials along with proof of Identity document.
- 11. If any candidates is found canvassing directly/indirectly, his/her candidature will be rejected summarily.

It is clarified that no individual call letters will be issued to the candidates.
