Applications are invited from eligible candidates who are citizens of India as defined under Articles 5 to 8 of the Constitution of India for engagement of **01 (One) Driver (Contractual)** under the establishment of the **District Legal Services Authority, Majuli.**

Who may apply?	A citizen of India as defined under Articles 5 to 8 of the Constitution of India.
Honorarium	Monthly remuneration of Rs. 15,000/- (Rupees Fifteen Thousand only) (Fixed Pay).
Age Limit	The candidate must not be less than 18 years and not more than 40 years of age as on the date of submission of the application. Age relaxation shall be as per Government norms for reserved categories.
Eligibility Criteria	The minimum educational qualification is HSLC Passed and the candidate must possess a valid LMV Licence .
HOW TO APPLY	1. Applications in the prescribed Standard Form of Application published in Part-IX of the Assam Gazette along with self-attested copies of all testimonials and two recent passport-size photographs (self-attested) , addressed to the Secretary, Office of District Legal Services Authority, Majuli, behind Circuit House, Garamur, PIN – 785104 , must be dropped in the "Drop Box for the Post of Driver (Contractual)" placed in the premises of the Office of the District Legal Services Authority, Majuli, on or before 07.08.2026 . Applications may also be submitted to the



office of the undersigned **by post/ courier** on or before the last date for receipt of applications.

2. Belated and incomplete applications shall be rejected summarily. The Authority shall not be responsible for delayed postal delivery of applications beyond the prescribed date.
3. Any application received by post/ courier or by hand after **07.08.2026** shall not be entertained.
4. Candidates submitting their applications by post/courier shall ensure that the applications are addressed to **The Chairman District Legal Services Authority, Majuli, (behind Circuit House Garamur), PIN – 785104** and reaches within the stipulated time i.e. by 5 PM on 07/08/2026.
5. The candidates shall be responsible for any postal/courier delay or non-delivery of their applications within the stipulated time.
6. The candidate must provide a valid contact number, preferably a WhatsApp-enabled mobile number, in the Application Form.

8. Applications submitted through any mode other than that indicated above shall be summarily rejected without any communication.

If a candidate is found to have suppressed his/her educational qualification or furnished any false information at the time of applying for the post, his/her candidature shall be liable to be rejected. 11. No individual call letters will be issued to the shortlisted candidates. 12. Canvassing directly or indirectly shall disqualify the candidature of the applicants. 13. No TA/DA will be admissible to the candidates for appearing in the selection process. 14. Mere inclusion of a candidate's name in the merit list shall not confer any right to appointment unless the Appointing Authority is satisfied, after such enquiry as may be considered necessary, that the candidate is suitable in all respects for appointment. 15. The Selection Board reserves the right to cancel, alter or modify this advertisement or any of its terms and conditions without assigning any reason or prior notice.
SELECTION PROCESS	<u>Stage-I (Skill Test):-</u> A Driving Test will be conducted to assess the candidate's driving skill, knowledge of vehicle maintenance and basic motor mechanics.



	Stage-II (Viva-Voce/Interview):- Candidates who qualify the skill test shall be called for the next stage, i.e., Viva-Voce/Interview. The final selection shall be made on the basis of the aggregate marks obtained by the candidates in the Skill Test and Viva-Voce/Interview.
