Applications are invited from the eligible Indian Citizens in the following prescribed format for preparation of separate panels to fill up the Existing and Expected vacancies, mentioned below in different categories of posts in this Judgeship for the year 2016.

The Examination/Test of a particular category of post will be held in a particularly day and time as per schedule to be declared later. One can apply for only one vacant post of this Judgeship. Details of vacancies, Scales of Pay, detailed address of the Appointing Authority to whom the application is to be addressed and in whose favour the respective application fee is to be deposited are detailed hereinbelow.

The appointments will initially be made on purely temporary basis, but likely to be made permanent for all categories of posts as per existing Rules and Notifications of the State Government for the time being in force.

(1) Mode of Examination:-

(A) <u>For Lower Division Clerk</u> :- A Written Examination in Two Parts shall be conducted. Only the successful Candidates of Part-I examination shall be called for Part-II Examination. The minimum Qualifying marks for both Part-I and Part-II shall be fixed by the District Recruitment Committee.

Part-I shall be of 100 Marks. The duration of the examination shall be 02 hours consisting of 100 Questions of 01 mark each with negative marking of the same mark in respect of each question. The question paper shall be of Objective Type consisting of English Grammar, General Studies and Arithmetic.

Part-II Examination shall be divided into two parts – Group (A)-English of 40 Marks, Group (B)-Bengali/Hindi/Urdu/Nepali. Translation, Letter writing in English and in Bengali/Hindi/Urdu/Nepali, Paragraph writing in English and Bengali/Hindi/Urdu/Nepali and Newspaper reporting in English and in Bengali/Hindi/Urdu/Nepali and knowledge of General Awareness/Studies of 60 Marks. The candidates who shall take Hindi/Urdu/Nepali, as the case may be, in lieu of Bengali Group- (B) of Part-II Examination shall be required to pass a Departmental Examination in Bengali during the Probation period in order to be considered for confirmation in service.

The successful candidates of part-I examination shall be permitted/allowed to appear in part-II examination in the ratio of 1:10.

After obtaining the minimum qualifying marks of Part-II Examination, the duration of which examination shall be of 02 hours, the successful candidates shall be called for viva-voce test of 10 marks in the ratio of 1:3 as far as practicable, when the test in computer knowledge for L.D.C. Candidates shall also be taken. On the basis of the results of written examination and viva-voce, the final panel shall be prepared. The standard of examination of both Part-I and Part-II shall be that of Madhyamik standard of West Bengal Board of Secondary Education.

(B) For Typist (Basic Grade) :- The candidates shall have to appear for (I) Preliminary Examination (Objective Type) of 100 Marks in the same criteria as that of Lower Division Clerk post as mentioned hereinabove and (II) Main Examination (Typing Test). The Preliminary Examination will consist of one paper having objective type multiple choice questions on General English (30 Marks) and Current Affairs with arithmetic (30 Marks). The duration of the Preliminary Examination shall be 02 hours. Only the successful candidates of Preliminary Examination shall be called for Main Examination (Type Test of 90 marks). Every candidate shall be required to type 450 words in 15 minutes from a manuscript of English Passage. The maximum number of mistakes is allowable is 05 percent. The appropriate authority shall have the discretion to fix qualifying marks for both Preliminary and Main Examination. On the basis of the result of the Main Examination (Type Test) a number of candidates will be selected for personality test carrying 10 marks in the ratio of 1:3 as far as practicable and at the same time the knowledge in computer operation shall also be tested. A final panel will be prepared on the basis of the result of the total marks obtained in typewriting, Computer Operation Test and Personality Test.

(C) <u>For Summons Bailiff</u>:- A written Examination, the duration of which shall be of 02 hours to be conducted by the Authority. Written Examination will be of 100 marks containing 50 Questions of 02 marks each with negative marking of the same mark in respect of each question comprising of General English, Arithmetic, General Studies . On the basis of the result of the Written Examination, a number of candidates will be selected and called for Personality Test of 10 marks in the ration of 1:3 as far as practicable and a final panel will be prepared.

N.B.:- For Application Format : (1) Sl. Nos.1– 11 and 14, 15 and 16 are required to be filled up by all the candidates applying for any category of Post and in addition to the other relevant particulars in respect of Sl. No.12 to be filled up by the candidates applying for the posts of Lower Division Clerk, Typist (Basic Grade) and optional for the posts of Summons Bailiff, Sl. No. 13 to be filled up by the candidates applying for the post of Typist (Basic Grade).

(12) Candidates called for the Tests shall be required to appear at their own expenses.

(13) Admission to the test/examination will be deemed provisional, subject to verification and determination of the candidate's eligibility and suitability in all respect. If at any stage of the process, a candidate is found to be ineligible for admission to the test in terms of the Notice, his/her candidature shall be cancelled without making any reference to him/her and without assigning any reason.
