Corrigendum Employment Notice No. PSC 02/16

In terms of G.O. No. 83 (30)-JD/X/16M-21/14 dated 05.04.16 of the Judicial Department, Government of West Bengal as received by this Office on 28.04.16 read with G.O. No. 1583-F (P) dated 21.02.12 of the Finance Department, Audit Branch, Government of West Bengal, the declared vacancy for 01 post of Typist (Basic Grade) in original Employment Notice No. PSC 01/16 dated 25.04.16 stands withdrawn from said Notice dated 25.04.16 since vide above G.Os' presently there is no vacant post for Typist as declared and the declared 01 vacant post in such cadre vide above Notice dated 25.04.16 shall be treated as 01 vacant post in the L.D.C. cadre (Group-C) of this Judgeship by following the guidelines of the above G.Os' and accordingly such previously declared vacancy now stands declared in the L.D.C. cadre post (Group-C) as a converted post in the following manner :-

2) As such, as of now, 02 posts for L.D.C. cadre and 02 posts for Summons Bailiff are presently available in this Judgeship in respect of Staff Recruitment for the current year, 2016.

3) The candidates who have already applied or would apply for the post of Typist vide above Employment Notice dated 25.04.16 would be treated as candidates applying for the post of L.D.C. and all the instructions and guidelines as are applicable in respect of such candidates applying for L.D.C. post would apply in verbatim for the said candidates who have applied or would apply for the post of Typist vide above Notice dated 25.04.16.

All the other instructions and guidelines as declared in the aforesaid original Employment Notice dated 25.04.16 alongwith all other portions thereof shall remain as it is and unaltered and this instant corrigendum Notice shall be treated as part and parcel of the above original Employment Notice dated 25.04.16.
