- a) The selected candidates shall be appointed purely on temporary basis and shall remain on probation for the period as provided in West Bengal Service (Appointment, Probation and Confirmation) Rules 1979. During his/her period of probation, if it is found that the candidate is not fit for the post then his/her period of probation shall not be extended and he/she shall be terminated from his/her post.
- b) If the candidate is already in Government Service either in any Judgeship or in any other Department of Government of West Bengal or Union of India, he/she shall submit a certificate issued by his/her Appointing Authority showing that there is no disciplinary proceeding pending against him/her for the charge of corruption, insubordination or for any other reason and there is no criminal case arising out of his/her rendering present service is pending or any other proceeding is pending against him/her.
- c) The candidates shall submit the certificates along with the filled up police verification forms. Non submission of such certificate shall be treated as violation of the norms of the selection and the name of such candidate shall be deleted from the successful candidates' list.
- d) The successful candidates shall collect his/her Police Verification Form from the Office of The Chief Judge, Presidency Small Cause Court, Calcutta within 13/02/15.
- e) The successful candidates shall submit duly filled in Police Verification Forms along with duly certified copy of his/her all educational qualifications along with the Police Verification Forms. In case of suppression of any education qualification by the candidate during submission of the Police Verification Form, it will be dealt with seriously and in future this department shall not give any credit or benefit to the candidate for such qualification in future.
