- Quotations should be submitted along with a copy of PAN and GST registration addressed to the Registrar, Presidency Small Cause Court, Calcutta on or before 16/12/2024 between **11 AM and 4:30 PM** on any working day and should be properly signed and stamp in the office of the English Department, Presidency Small Cause Court, Calcutta on the Sixth floor of the City Civil Court Building. Authority will not take responsibility for delay, loss or non-received quotation send by the post. The envelopes will be opened on 17/12/2004 at 3:30 P.M. at the chamber of the Registrar of this Court.
- Rates should be quoted taking into account the description, make, type, specification and quantity of the articles for which quotations have been invited.
- **Rates quoted should be inclusive of all applicable charges, taxes, duties and levies.**
- If the quotation of any supplier, which is not enlisted with this authority, is selected, the concerned supplier, the concerned supplier may have to submit copies of such documents as Trade License and/or PAN etc. as and when the Registrar, Presidency Small Cause Court, Calcutta may direct.
- Conditional quotations will not be considered.
- Willing supplier submitting quotation should specify the address of its office and its Phone/Mobile number (and other contract numbers e. g. Fax, if available) for canvassing on the part of a supplier submitting quotation will render its quotation liable to cancellation summarily.
