### Terms and Conditions:

1. Candidates must be an Indian Citizen defined in Article 5 to 8 of the Constitution of India.
2. Candidates must not be less than 18 years or more than 40 years of age on 01.01.2024 (5 years relaxation for ST/SC candidates, 3 years relaxation for OBC/MOBC candidates, 2 years relaxation for Ex-Serviceman and 10 years relaxation for PWD candidates).
3. Candidates must have registered their names in the Employment Exchange and the Registration numbers alongwith date must be mentioned in their applications.
4. Candidates serving in Govt. Department should submit their application through proper channel.
5. The applications with self attested photocopies of all relevant testimonials regarding Educational Qualifications, Experience Certificate (wherever applicable), Caste, Age Proof, Employment Exchange Registration Card along with 5 (five) recent (taken after 01.01.2024) passport size photographs duly signed by the candidate on the reverse side along with an undertaking that the candidate has not passed HSSLC examination should reach the office of the undersigned on or before **01.04.2024**.
6. Candidate must provide their email address and mobile numbers in the application form without fail.
7. Candidate must indicate prominently the name of the posts applied for on the top of the envelope containing the application.
8. The last date of receipt of application is **01.04.2024 by post or through the drop box** provided within the court complex. No application will be entertained after the last date. The appointing authority shall not be responsible under any circumstances for any postal delay.

9. Eligible candidates for the post of peon will have viva-voce test only.
10. No individual call letters/admit cards shall be sent to the eligible candidates. List of the eligible candidates to be called for viva voce test, will be uploaded in the official website. The list of rejected candidates will also be uploaded in the official website. Candidates are advised to check the official website and notice board of the office of the undersigned regularly.
11. Place and Date of viva-voce test will be uploaded in the official website of District Judiciary, Dhemaji.
12. No TA/DA will be admissible to the candidates for appearing in the viva-voce test etc.
13. If any candidate is found to have suppressed his/her educational qualifications or given any wrong information at the time of applying for the job or later on, his /her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to Criminal Prosecution as per law.
