In pursuance of this Office Notification dated Dhemaji the 29<sup>th</sup> of March, 2025 and in the interest of public service, the undersigned is pleased to temporarily appoint **Sri Pranjal Dutta**, C/o Bireswar Dutta, Ward No. 7, Vill.- Nagakhelia, P.O.- Nagakhelia, P.S. & Dist.- Dhemaji, Pin-787057, to the post of Peon, in the office of the District & Sessions Judge, Dhemaji, w.e.f. the date of his joining, **in the scale of Pay Band Rs. 12000-52000 + Grade pay Rs. 3900/- per month plus other allowances** as admissible under the rules subject to the condition that in the event of adverse police verification report, his services will be terminated forthwith without assigning any reasons thereof.

The incumbent shall have to submit an undertaking to that effect at the time of joining this establishment.

He will be **on probation for a period of 2 (two) years with effect from the date(s) of his joining.**

The post was originally sanctioned by the Govt. of Assam vide Memo No. LJJ.413/73/43, Dated 07.11.1979.
