- 2. The sealed envelope containing quotation shall be marked as "Tender for Supply of COMPUTER & PERIPHERALS" and the following documents must be annexed with the quotation.
 - a. Copy of PAN card.
 - b. Proof of valid TIN number.
 - c. Up to date copy of GST/VAT Registration Certificate.
 - d. Up to date copy of AGST/VAT Clearance certificate.
 - e. Copy of Trade License in Assam.
- 3. Rate should be quoted with GST and without GST separately. Taxes/VAT is to be shown separately against the items in the bills, where applicable, which will be deducted at source.
