- 4. The candidates for the above mentioned post will be selected on the basis of Viva-Voce.
- 5. No TA/DA will be admissible to the candidates for appearing in the Viva-Voce.
- 6. Incomplete/ineligible application and in any other written respect against the criteria will be rejected without assigning any reason.
- 7. The inclusion of candidate's name in the list shall confer no right to appointment unless the appointment authority is satisfied after such enquiry as he may consider necessary that the candidate is suitable in all respect for appointment.
