In view of the establishment of the Chief Judicial Magistrate, Suryapet, it is felt necessary to issue revised arrangements for attending the work recording Section 164 of Cr.P.C. statements of witness and for conducting Test Identification Parade of Accused as detailed below in supersession of the earlier circulars in the reference cited above.

Note: As the post of JMFC, Thungathurthy is kept vacant, the P.O. JMFC, Kodad is directed to entertain the requisitions till the posting of Regular Officer.

All the Judicial Magistrates of First Class who are nominated as cited above for recording of the Sec. 164 Cr.PC statements and for conducting Test Identification Parade of accused shall follow the guidelines and orders vide reference cited scrupulously and conscientiously.

Further all the Judicial Magistrates of First Class, Suryapet District are directed to not to entertain any requisition from the police for recording Sec. 164 Cr.P.C. Statement and conducting of Test Identification Parade of Accused under SCs/Sts (POA) Act, 1989 directly and they shall record the statement of witness/ conducting of Test Identification Parade of accused on their nomination by the Chief Judicial Magistrate only. All the Judicial Magistrates of First Class, Suryapet District Unit are directed to follow the circular fastidiously without any deviation until further orders.

This Circular will come in to force with effect from this day.
