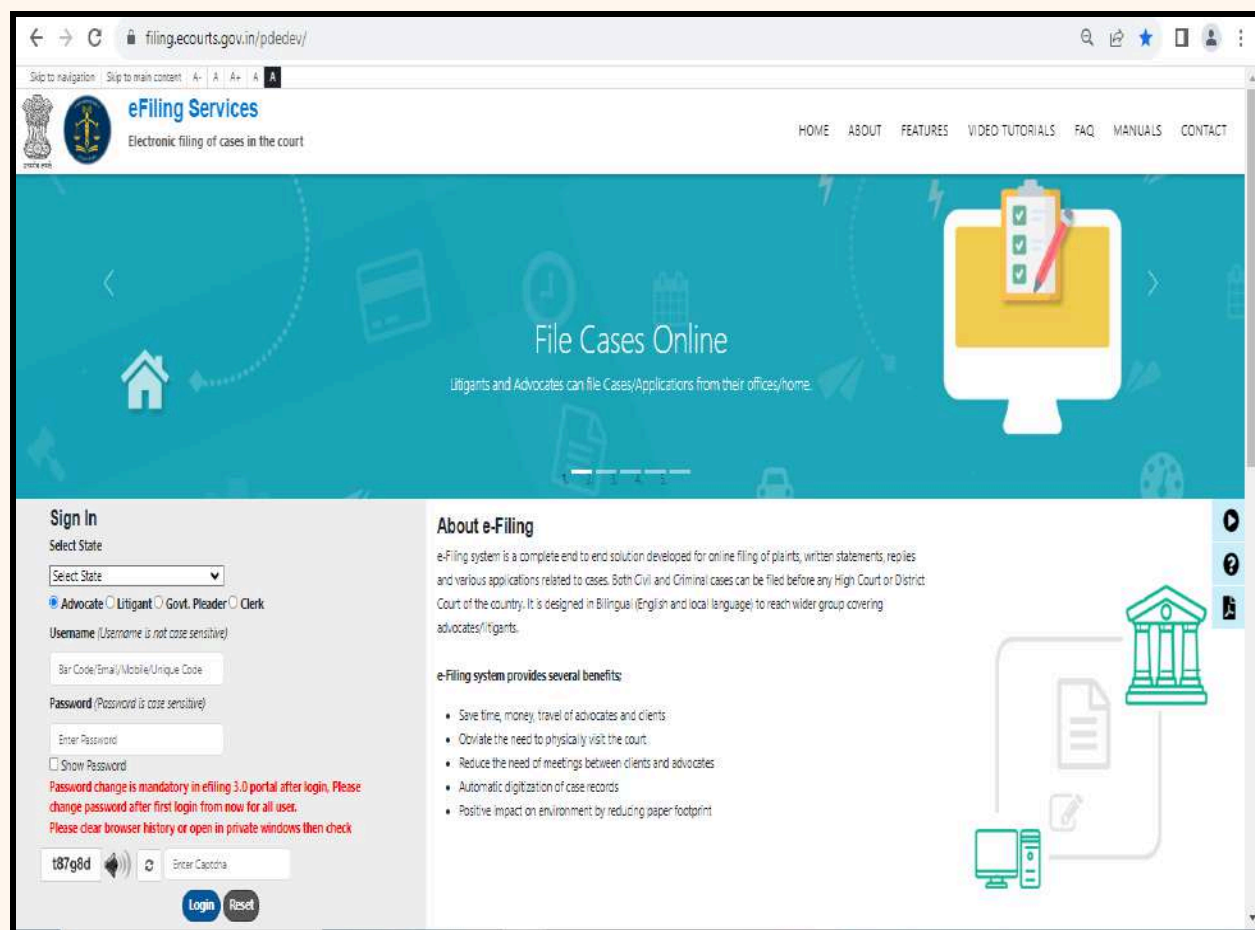
## Inauguration of e-Sewa & Suvidha Kendra in Rouse Avenue Court, New Delhi

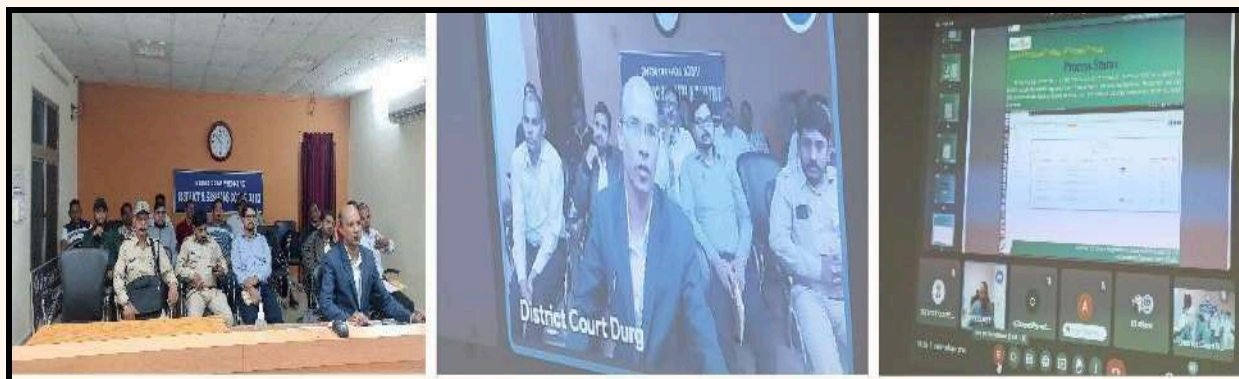
## High Court of Meghalaya Conducts Training on NSTEP

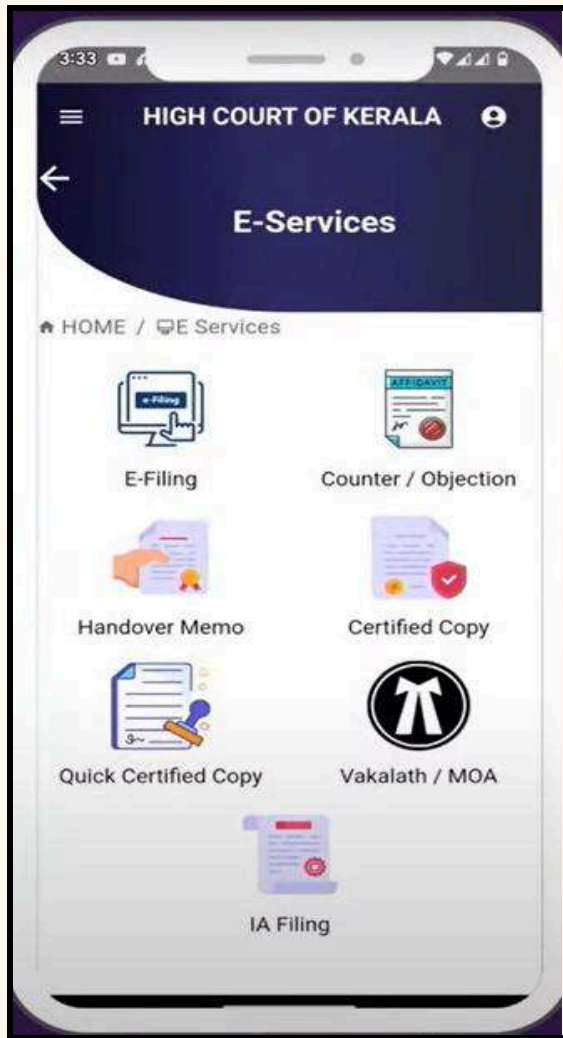

**App For Judges Dashboard: A. Mobile App for e-filing:**  
The Kerala High Court's groundbreaking mobile application for e-filing is a game-changer in the realm of legal technology. It offers individuals a highly efficient and user-friendly means to initiate the legal process. This innovative platform has successfully integrated all web application e-services into a single mobile app, simplifying the



complexities of the legal system and enabling e-filers to submit a case within a remarkably short 10-minute window. It is indeed the very first court e-filing application of its kind to be developed in the country,

highlighting the Kerala High Court's unwavering commitment to modernising the legal system. Here are some of the key features and functionalities that this pioneering mobile app brings to the fingertips of users:

- Petition Filing
- Counter/Document Filing
- Comprehensive Case Viewing
- Certified Copy Requests
- Urgent Memo Submission

## B. Mobile App for Judges Dashboard



The Judges Dashboard Mobile App represents a significant advancement with streamlined access to web application e-services. This innovative application has been meticulously designed to cater to the specific needs and demands of the judiciary, offering a comprehensive suite of tools and features. At its core, the Judges Dashboard mobile app is engineered to provide judges with efficient and convenient access to the full spectrum of web application e-services. The key

features and benefits include Comprehensive Access, Case File Management, Document Review, Mobility and Productivity, Streamlined Decision-Making, Office Communication, Case List as per Cause List, CR (Certified for Reporting) Judgement Search, Access to Law Journal, Reports and Graphs of Pendency and Disposed Cases. **2: Former Judges**

**Dashboard:** The Former Judges Dashboard serves as a platform for former judges to submit various grievances related to their post-retirement benefits, medical reimbursements, pension-related issues, police protection, and other administrative matters. It facilitates effective communication and support for retired judges. **3: Machine Scrutiny Of Writ Appeal Filing:** The Kerala High Court has extended its machine scrutiny

system to include writ appeals. This automated scrutiny process reduces the need for human intervention, resulting in faster case registration.

#### **4. Introduction of e-filing, e-payment in Vigilance Courts and Vigilance FIR**

**Integration:** Starting from 01.11.2023, mandatory e-filing has been instituted across all the Courts of Enquiry Commissioner and Special Judge (Vigilance), while optional electronic payment has been adopted in all the Courts of Enquiry Commissioner and Special Judge (Vigilance) except Kozhikode. The Vigilance Case Management System and the Vigilance Court FIR System have been linked to speed up the transmission of FIRs to Vigilance Courts. This integration automates the process of transmitting FIR details to the court, accelerating case initiation and improving efficiency. The same has been made available w.e.f 15.11.2023.

#### **5. District Court Case Disposal Monitoring and**

**Reporting System:** The District Court Case Disposal Monitoring and Reporting System is a module developed to monitor and manage the case disposal rates of district court establishments. This system replaces the manual method of transferring reports and allows concerned officers to track and access district court disposal reports through the high court's case management system. Other e-initiatives are: **1. Prisoners Database Integration with High Court and District Court System:** To track accused individuals in custody and link prison details with case parties, a software system has been developed. This database allows prison officials to input prisoner data, making it easier to identify and prioritise cases involving accused individuals in custody. The core objective of this integration is to provide an accurate and up-to-date tracking system for accused

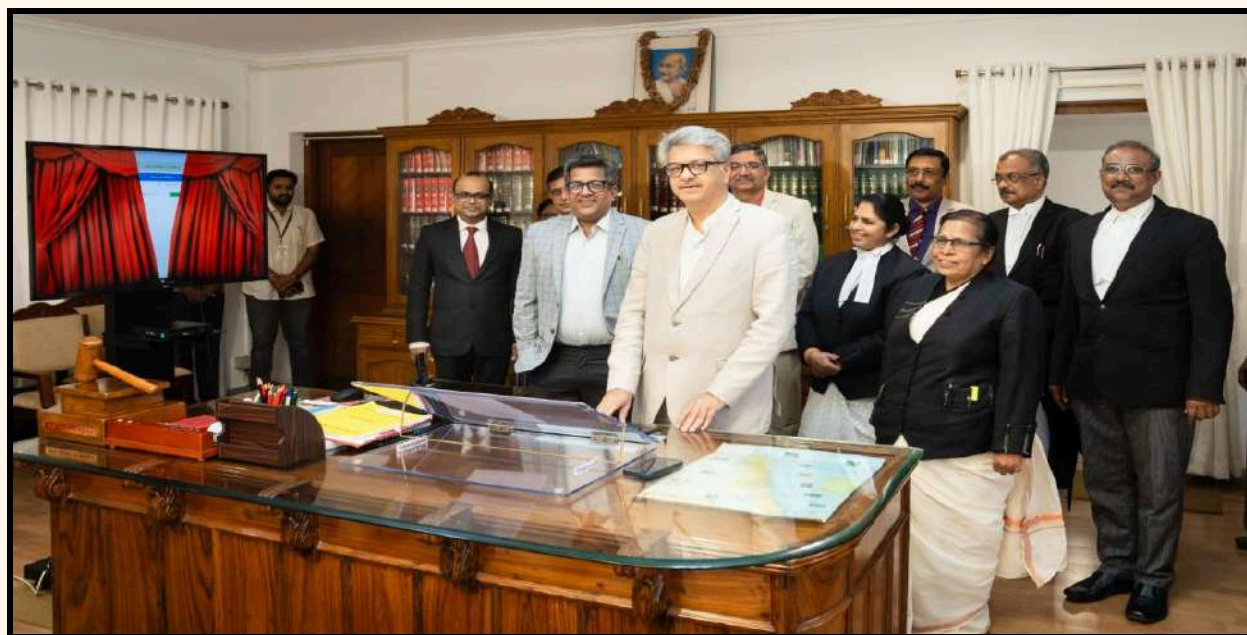
individuals in custody. **2: F.I.R integration with KELSA and DLSA for Victim Compensation Scheme:** In light of the court order (CRL.MC NO. 3531 OF 2022), the Kerala State Police Chief has been directed to integrate the Kerala State Police IT system with the Kerala Legal Services Authority (KeLSA) to enable the seamless sharing of soft copies of FIRs immediately upon registration with KeLSA or the District Legal Services Authority (DLSA). This initiative is a significant step towards streamlining the process of legal support and action, ensuring that DLSA can promptly respond and act upon receiving the necessary information. **3: Digital Monitoring System for issue and service of process in Criminal Courts:** To facilitate communication between courts in district judiciary and police department using API services, NIC High Court unit has developed an

API, under the guidance of the Hon'ble High Court of Kerala, that allows the Courts to send Summons, Notices, and Warrants to police officers and receive compliance reports from the police department. The web service acts as a bridge between the Digital Court and CIS applications of district Judiciary and iCops application of the police department. Processes received in iCops will then be accessible to concerned police stations for execution. **4: Voice-to-Text Judgment Drafting:** The Voice-to-Text judgement Drafting system incorporates voice-to-text technology into the judgement drafting process, enhancing efficiency and accuracy. This feature, initially introduced for interim orders and judge notes, has now been extended to all judgement drafting and digital signing processes. **5: Customised Anuvadhini Voice**

**Recording tool for recording deposition:** Kerala High Court has introduced the Customised Anuvadhini Voice Recording Tool, designed specifically for real-time transcription during depositions. This tool represents a significant leap in leveraging cutting-edge technology to streamline the documentation process. The Key Features includes Real-time Voice-to-Text Transcription, Multi-language Support, Customization for Legal Proceedings, User-Friendly Interface. **6: Implementation of Case Management System for LSG Tribunal:** The Local Self Government (LSG) Tribunal is entrusted with the responsibility of reviewing, considering, and adjudicating appeals and revisions against the decisions made by local bodies. To streamline and enhance the efficiency of these processes, the Kerala High Court is set to introduce

a comprehensive Case Management System for the LSG Tribunal. The Key Features includes Online Case Filing, Tribunal Secretariat Scrutiny, Automated Cause Listing, Court Proceeding Menu, Judgment Upload Provision, Integration with High Court System, Case Status Module for Public Access. **7: Third Phase-Implementation of eOffice in the District Judiciary:** With effect from November 1, 2022, all courts in the Kasargod and Thodupuzha judicial districts adopted the first phase of the e-Office in the District Judiciary.
