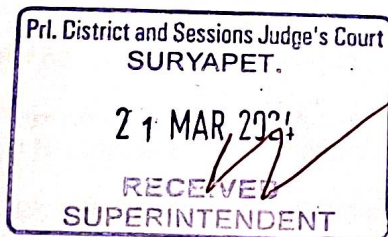

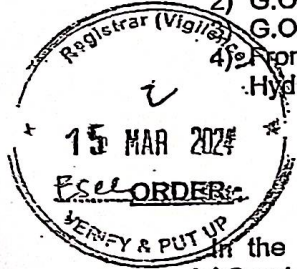

In the G.O. 1<sup>st</sup> read above, orders were issued establishing 36 Fast Track Special Courts in the cadre of Additional District and Sessions Judge for a period of one year with effect from the date of issue of the order for expeditious trial and disposal of Rape and Protection of Children against Sexual Offences (POCSO) Act cases in all Districts in the State of Telangana. In the G.O. 2<sup>nd</sup> & 3<sup>rd</sup> read above, orders were issued continuing the 36 Fast Track Special Courts for expeditious trial and disposal of Rape and POCSO Act cases, for a further period time to time.

2. In the letter 4<sup>th</sup> read above, the Registrar (Vigilance), High Court for the State of Telangana at Hyderabad, has stated that the continuance of the 36 Fast Track Special Courts in the cadre of Additional District and Sessions Judge in the State of Telangana for expeditious trial and disposal of the Rape and POCSO Act cases is very much required for expeditious trial and disposal of the Rape and POCSO Act cases, since the pendency in the Subordinate Courts is escalating day to day and the existing regular Courts are overburdened with heavy pendency. Therefore, he has requested to issue orders for further continuance of 36 Fast Track Special Courts for expeditious trial and disposal of Rape and POCSO Act cases in the State of Telangana, beyond 31-03-2023 i.e., from 01-04-2023 to 31-03-2024.

3. Government after careful examination of the matter, hereby continue 36 Fast Track Special Courts for expeditious trial and disposal of Rape and POCSO Act cases in the State of Telangana as established in the G.O. 1<sup>st</sup> read above, for a further period of one year i.e., from 01-04-2023 to 31-03-2024.

4. The Registrar (Vigilance), High Court for the State of Telangana at Hyderabad, shall take necessary action in the matter accordingly.

5. This order issues with the concurrence of Finance (HRM.II) Department, vide their U.O.No.1851995/26/A1/HRM-II/2023, Dated:20-02-2023.


