In partial modification of Circular ROC No. 549 / WRC/2012, dated 05.10.2012, the requirement of Qualitative work review of Judicial Officers of the State twice a year is dispensed with, as the aspect of qualitative work review is adverted to by the Administrative Judges while recording the Annual Confidential Reports.

All the Unit Heads are therefore instructed not to send two selected Judgements for the purpose of Qualitative assessment, while forwarding the work review statements of the officers.

However, the quantitative work review statements of the Judicial officer have to be submitted promptly at the end of every block period of six months i.e., January to June and July to December, to the statements of the Hon'ble Administrative Judges for their formarks.

These instructions will come into effect from II period of 2024.
