**Sub:** High Court for the State of Telangana –Mandatory Registration of Mobile Number and email address of all Advocates and Parties-in-Person in High Court and subordinate Courts in the CIS Software – Regarding.

With an endeavor to provide various services, all the Advocates and Parties-in-Person practicing in High Court and Subordinate Courts in the State of Telangana are requested to mandatorily Register their Mobile Number and email address along with their Bar Council Registration number without delay in Case Information System Software of practicing Courts. Presently, the Registry is finding it difficult to provide services offered by the Courts like messaging about Case information at each Stage (Filing, Objections and Registration), Personalized Causelist, Next date of hearing, Order availability on the Website etc., due to non-availability of Mobile Number and e-mail address of many Advocates and Parties-in-Person in the Court database. The Mobile number and email can also be used to authenticate the Advocates or Parties-in-Person to log into the Court Video Conferencing sessions, e-Filing portal and other applications for authentication purposes (OTP, Password).

Further to the reasons cited above and in obedience to the directions of the Hon'ble the Chief Justice, all Advocates and Parties-in-Persons who are filing the cases in High Court and Subordinate Courts shall compulsorily Register/Update their Mobile Number and e-mail address along with the Bar registration Number by approaching their respective Courts of Practice.

All the Unit Heads are hereby directed to follow and bring the instructions to the notice of the Bar Association(s) at District and Taluka levels for coordinating with the Advocates for capturing the requested data, at the earliest.
