03. Sealed tender should be sent in the office of the District Judges Office at Kalimpong within 28.09.2023 up to 12:30 pm.



05. For administrative convenience and on the basis of technical specification, the work may be divided amongst the bidders at the lowest accepted rate. The decision of the authority shall be final.
06. Only one representative of each bidder shall be allowed to attend at the time of tender opening subject to presentation of authorization letter from the Tenderer.
07. In case of any deviation from any terms and condition of order authority shall reserve the right to cancel the order with the supplier at any time during the aforementioned period.


