This is for information to those candidates who appeared in the written examination held on 03.10.2021 at Kalimpong relating this Court's Notification No.RC-01/2019 dated 19.12.2019 read with Notification No.R-05/2021 dated 07.10.2021 for filling up **two (02)** vacancies of English Stenographers [**1-UR; 1-SC**], a number of candidates have been short listed from the list published on 07.10.2021 on the basis of marks secured by them.
