On the basis of marks obtained in Paper-II, Paper-III, Personality Test and Computer Operation test (Total 50 + 50 + 30 = 130), one merit list has finally been prepared. As per notifications numbers RC-01 of 2019 Dated: 19.12.2019; R-04/2021, dated 07.10.2021; R-09/2021, dated 14.10.2021 and R-13/2021, dated 24.11.2021, three stage examination held for the Category, Nepali Translators (**Group-B - Upper Division Assistant**) comprised of MCQ Paper of 100 marks (**03.10.2021**), Written Paper of 100 marks (**13.11.2021**) and Personality-cum-Computer Operation test of 30 marks (**04.12.2021**).
