Applications are invited from the local residents in the prescribed form along with two numbers of passport size photographs, for empanelment of 08 number of Para Legal Volunteers/Adhikar Saathi ('PLV' in short), who are willing to serve as Para Legal Volunteers/Adhikar Saathi under District Legal Services Authority, Kalimpong. The applicants should have the following qualifications to apply for empanelment as Para Legal Volunteers/Adhikar Saathi .

- 1. He / She must be a citizen of India.
- 2. The applicants must have passed minimum matriculation or equivalent examination with a capacity for overall comprehension and should have the mindset to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society. They must have the unflinching commitment towards the cause which should be translated into the work they undertake.
- 3. Preferably the Para Legal Volunteers/Adhikar Saathi shall be selected, who do not look up to the income they derive from their services as Para Legal Volunteers/Adhikar Saathi, but they should have the mindset to assist the needy in the society.
- 4. The applicant should not be less than 21 years as on the date of advertisement.
- 5. The work of Para Legal Volunteers/Adhikar Saathi does not carry any salary, remuneration or wage except remuneration fixed by District Legal Services Authority, Kalimpong from time to time, as per rules.
- 6. The duly filled up application along with photocopies of supporting credentials and 2 (two) copies of recent passport size photographs, should reach the office of the Secretary, District Legal Services Authority, District Judge's Court complex, Kalimpong on or before 4.00 p.m. on **24.02.2025**. The applicants should submit their mobile / contact number in their application for communication, if required.
- 7. Incomplete applications shall be rejected without assigning any reasons thereof. No application shall be entertained after the date and time specified above.
- 8. The decision of the Selection Committee in short listing the number of candidate for interview and empanelment of Para Legal Volunteers/Adhikar Saathi shall be final. They will be empaneled as per the provisions of NALSA (Scheme for Para Legal Volunteers (Revised) & Module for the orientation-induction-refresher courses for PLV Training.
- 9. Empaneled Para Legal Volunteers/Adhikar Saathi shall be required to undergo training programme as per decision of the District Legal Services Authority, Kalimpong.
- 10. In case of any objection regarding selection of Para Legal Volunteers/Adhikar Saathi the decision of Chairman, District Legal Services Authority, Kalimpong shall be final and binding to all concerned.
- 11. List of eligible candidates shortlisted for interview and subsequently the list of final candidates for empanelment, will be notified in the Official Notice Board and will also be uploaded in the Official Website of Kalimpng District Judiciary i.e. https://districts.ecourts.gov.in/kalimpong.
- 12. Canvassing of any kind, direct or indirect, shall disqualify the candidate.
- 13. No TA/DA will be provided for appearing in the interview.
