
In pursuance to Advertisement dated 25/11/2024 and as per resolution adopted by the Selection Board, the **accepted and rejected list for the post of Process Server with reason of rejection thereof are hereby uploaded in the official website (<https://southsalmara.dcourts.gov.in>)**. All accepted candidates are hereby asked to visit the official website to download Admit Card. The **Admit Card** will be available in the official website from **08/04/2025 onwards**. The **Written Examination of 100 marks will be held on 26/04/2025** from 11:00 AM to 01:00 PM and the **Viva-Voce/Interview of 51 Marks will be held on 27/04/2025 from 11.00 AM onward**. The Venue of the Written Examination will be mentioned in the Admit Card. Candidates are requested to download their Admit Card from Official Website. **No separate call letters will be issued to the candidates individually.**

Terms and conditions for the candidates:

1. Candidates are requested to bring Admit Card to the examination hall. Without the Admit Card, the candidates will not be allowed to sit in the examination.
2. Every candidate should bring at least one photo identity card (Aadhar card, Driving license, voter ID card, PAN Card etc) issued by the Government Authority without fail.
3. Candidates are to report at the venue of the examination hall half an hour prior to the commencement of the examination.
4. No candidate will be allowed to enter the examination room/hall after 20 minutes of the commencement of the examination.

5. Only one answer sheet will be provided to the candidates for the purpose of the examination. Therefore, candidates are directed to carefully fill up the Roll Nos etc.
6. Candidates are directed to bring their own **ball-point pen (blue/black)** for the purpose of marking/writing the answers on Answer Sheet.
7. No candidate will be permitted to leave the examination hall during the two hours of the examination.
8. Carrying of bags, books, mobile phones, calculators and any other electronic gadgets inside the examination venue is strictly prohibited.
9. Candidates found in possession of mobile phones or such electronic gadget(s) during the time of examination will be disqualified.
10. Violation of any of the above instructions and adoption of any unfair means in the examination will entail cancellation of their candidature.
11. The issuance of this Admit Card will be purely provisional and it does not mean acceptance of the candidature of any candidate. The Authority reserves the right to reject candidature of any candidate at any time. Please note that your candidature shall be subject to fulfillment of all criteria mentioned in the advertisement dated 25/11/2024.
12. Discrepancy, if any, noticed in the Admit Card should be brought to the notice of the undersigned, in writing within 7 days from the publication of Admit Card.
13. No TA and DA will be paid for appearing in the said examination.
14. A candidate must secure at least 45% marks in the written test i.e. 45 out of 100 marks in order to be qualified for appearing in the Interview/Viva Voce.




