*In terms with the advertisement, Written Examination of 50 marks will be held to test the knowledge of English, General Awareness, Mathematical Ability, Aptitude and knowledge of Assamese language etc. **Duration of examination will be 01 hour (60 minutes).***

In terms with the advertisement dated 09/01/2026 candidates equals to three times the number of vacancies out of the qualified candidates (1:3) in order of merit in the written examination will be called to appear in the Interview/Viva Voce. A candidate must secure at least

50% marks in the **Written Examination** i.e. 25 marks out of 50 marks for the post of Peon in order to be qualified for appearing in Interview/viva-voce.
