
**HOW TO APPLY :-**

3. The candidate must write "**Application for the post of ----- (name of the post for which the candidate would applied for)**" on the top of the envelop accompanying the application.

**The last date of receipt of duly filled up applications is 18.04.2023. No applications shall be accepted nor any postal delay be considered after the last date.**


