## B. Submission of Quotation:

- The quotation in sealed cover should be sent to the office of the District & Sessions
  Judge, Hojai, Assam by post or hand delivered.
- Interested Registered firms/Press must submit their quotation in two separate sealed covers as per the format enclosed as Annexure 'A' and Annexure 'B'. Both the bids should be kept together in another sealed cover superscripted as "Quotation for supply of Registers and forms".
- The quotation in sealed cover containing the bids must reach the designated office on or before 13<sup>th</sup> August, 2021 within 4 P.M. Bids received after the due date/ time shall not be entertained.
- 4. The received bids shall be opened in this office on 16.08.2021 at 3 P.M. in the presence of the bidder or their authorized representative. All the bidders may remain present either in person or through authorized representative on aforementioned date and time in the office of the undersigned.
- Incomplete quotation or bids not accompanied with the requiring supporting documents or quotation without sealed envelope shall be summarily rejected without assigning any reason and without any communication.
- This office shall reserve the right to reject any bid without assigning any reasons if th bidding appears to be unreasonable.
- The rates quoted shall be valid for one year from the date of awarding the work of Printing and supply by the office of the District & Sessions Judge, Hojai.
- 8. The tenderer should indicate the paper qualities (GSM) along with the bid.
- TDS will be deducted at the applicable rate from the contract amount.
- 10. The financial bid must mention the rate to be charged by the firm as per the following terms and conditions.

### C. Terms and Conditions:

The firm / Press shall abide by the following terms and conditions.

The bidder must be a registered firm / Press and must submit the necessary documents as follows.

- Proof of Current Bank Account of nationalized Bank in the name of the firm.
- ii) Trade license issued by appropriate authority.
- iii) PAN Card in the name of the firm.
- iv) GST registration certificate.

- Any other documents which are required for supplying of tendered items to the Govt. Office.
- 2. The rates should be submitted with GST and without GST separately.
- The rate quoted for each item will be final and in no hike in price shall be considered in the contract period. Further, rate quoted in the price bid should be on door delivery to this establishment.
- Preference shall be given to Firm which has experience in dealing with supply of Forms and Registers to the Govt. Offices/ Departments.
- The bidder shall have to supply the ordered items immediately on receipt of such supply order. The articles to be supplied should be of best and standard quality.
- Payment shall be made after satisfactory execution of the order and supply of material in satisfactory condition in bill basis.
