**NOTICE/ADVERTISEMENT FOR ENGAGEMENT OF PLV UNDER DLSA, HOJAI**

*Applications are invited from the local residents in standard form as published in Assam Gazette in part-IX along with two number of passport size photographs and Self-address stamped envelope, for selection of around 40 numbers of PLV's who are willing to serve as Para Legal Volunteers at Hojai district under District Legal Services Authority, Hojai, Sankardev Nagar. The applicants should have the following qualifications to apply for the selection of Para Legal Volunteers:*

**1. He/ She must be a citizen of India and should be from any one of the following groups:**

**(a) Teachers (including retired teachers)**

**(b) Retired Government servants and senior citizens.**

**(c) Masters of Social Work students and Teachers.**

**(d) Anganwadi Workers.**

**(e) Doctors/ Physicians.**

**(f) Students & Law Students (till they are enrolled as lawyers)**

**(g) Members of non-political, service-oriented NGOs and Clubs.**

**(h) Members of Women Neighbourhood Groups, Maithri Singhams and other Self-Help Groups including Marginalized/ Vulnerable groups.**

**2. The applicants should pass minimum matriculation with a capacity for overall comprehension and should have the mind set to assist the needy in society coupled with compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society. They must have the unflinching commitment towards the cause which should be translated into the work they undertake.**

**3. Preferably the PLV's shall be selected, who do not look up to the income they derive from their services as PLV's, but they should have a mind set to assist the needy in the society**

**4. The minimum age for the selection of Para Legal Volunteer should not be less than 21 years as on date of notice.**

5. The work of PLV's does not carry any salary, remuneration or wage except honorarium fixed by District Legal Service Authority, Hojai from time to time, as per rules.

6. The filled-up application should reach the Office of, District Legal Authority, Hojai, Sankardev Nagar, Hojai Judicial Court Campus on or before 30/04/2024 at 5:00 PM **The applicants should submit their Mobile number and email id's in their applications for further communication, if any.**

**7. Incomplete applications will be rejected. No applications will be entertained after the last date fixed.**

**8. The decisions of the selection committee in short listing the number of candidates for interview and selection or PLV shall be final. They will be selected as per relevant Scheme, in this regard.**

**9. Selected PLV shall be required to undergo training programme as per decision of the District Legal Service Authority, Hojai**

**10. In case of any objection regarding selection PLV's the decision of Chairman, District Legal Service Authority, Hojai Shall be final and binding to all concerned**

**11. List of shortlisted eligible candidates will be notified in the official Notice Board as well as uploaded in the official website of Hojai District Judiciary i,e <https://hojai.dcourts.gov.in> for interview.**

**12. Canvassing directly or indirectly will disqualify the candidate.**


